

SUMMARY:

The Department of Health Care Services (DHCS) annually allocates State funding to Tulare County to provide Substance Use Disorder (SUD) Treatment and Prevention programs for Tulare County beneficiaries. Residential programs provide

housing for males and females, as well as the perinatal female population. The Outpatient Drug Free (ODF) program serves adults and youth consumers. This funding also supports Narcotic Treatment Programs and various SUD Prevention Treatment modalities throughout the County.

In response to a Corrective Action Plan by the Centers for Medicare & Medicaid Services (CMS), DHCS modified their State-County Contracts. Beginning January 1, 2019, DHCS will begin reimbursing Tulare County quarterly based on actual expenses, rather than advancing payments on a quarterly basis. Additionally, Recovery Residences program was also added to the agreement, which will allow Tulare County to reimburse for beneficiaries who are in temporary housing (up to 24 months), while remaining in treatment programs.

The following terms deviates substantively from the standard County boilerplate: 1) County must sign first; and 2) This is a multi-year agreement.

FISCAL IMPACT/FINANCING:

The revenue for this agreement increased by \$30,306 totaling \$6,635,313, out of which \$2,201,669 was included in Fiscal Year 2017/2018 budget, and \$2,231,975 was included in Fiscal Year 2018/2019 budget and \$2,201,669 will be included in the Fiscal Year 2019/2020 proposed budget. There is no additional net cost to the County General Fund.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic plan includes the Quality of Life Initiative that encourages innovative provision of quality supportive services for at-risk adults, youth and children in state and federally mandated programs. This agreement increases the ability to fulfill that obligation through Residential, Recovery Residences, ODF and transitional programs.
