Approve a budget adjustment to fund Burrel Avenue office work

space improvements

#### REQUEST(S):

That the Board of Supervisors:

- 1. Approve a transfer in an amount not to exceed \$200,000 from the District Attorney's Office department budget (001-100-3200-9102) to Capital Projects (030-086-3200-9202) for Fiscal Year 2018/19 to cover the costs for improvements to work space at the District Attorney's Burrel Avenue office.
- 2. Approve the necessary budget adjustment per the attached AUD 308 (4/5ths vote required.

#### **SUMMARY:**

The Tulare County District Attorney's Office is requesting that the Board approve the attached AUD 308 to transfer \$200,000 from the District Attorney's Office Capital Purchase appropriation to Capital Projects. These funds will be used for general improvements to retrofit vacant work space at the department's Burrel Avenue location. Work will include the creation of a storage area, installation of walls and doors and ceiling replacement. These improvements will fulfill the need for a private location to secure sensitive case information. In addition, several work stations will be created and furnished.

The projected cost of this work will not exceed \$200,000, and is expected to be completed by the end of calendar year 2019. The department will utilize savings in its Capital Purchase budget to cover all costs. Capital Projects will be managing the coordination of the project. These funds will increase the Capital Projects' overall

budget for Fiscal Year 2018/2019 and will need to be recognized as additional revenue.

#### FISCAL IMPACT/FINANCING:

The District Attorney's Office improvement project expenses in an amount not to exceed \$200,000 will be covered by the department's current savings in its Capital Purchase line for Fiscal Year 2018/19. There will be no net County cost to the General Fund.

#### LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic plan includes the Organizational Performance initiative to continuously improve organizational effectiveness. These improvements will provide much needed employee work space, as well as a secure facility for evidence storage.
