**SUBJECT:** Naming of County Park in Goshen

**REQUEST(S):**

That the Board of Supervisors:

1. Approve "Community Park of Goshen" as the new name for the 11<sup>th</sup> Tulare County Park located in the community of Goshen in accordance with County Administrative Regulation No. 12.

**SUMMARY:**

On September 11, 2018, the General Services Agency (GSA) Parks & Recreation (Parks) Division assumed responsibility for a combination drainage basin and park space located at 6800 Ave 310 in the community of Goshen, which was constructed as part of a Tulare County Redevelopment Agency (TCRA) railroad crossing grade separation and realignment project.

Following TCRA's dissolution, the County Resource Management Agency (RMA) assumed responsibility for the property and considered closing the area to the public and maintaining it only as a storm drainage basin. However, due to the lack of other recreational spaces in Goshen, and the community's frequent use of the property for sports activities, the property was transferred to the Parks Division to maintain as the 11<sup>th</sup> County Park.

On November 8, 2018, the Parks Division held a community outreach meeting in Goshen to gather input from the community regarding desired improvements and to suggest a name for the newly acquired County Park. On December 4, 2018, the Park Advisory Committee (PAC) was presented with three name suggestions proposed by the community at the outreach meeting: Community Park of Goshen,

Goshen Community Park, and Goshen Sports Complex. The PAC recommended to bring the "Community Park of Goshen," to the Board of Supervisors for consideration. Two residents of Goshen currently serve on the PAC.

Therefore, in accordance with Administrative Regulation No. 12, which states that subcommittee-reviewed proposals to name property must be forwarded to the Board of Supervisors for consideration, it is requested that the Board consider and approve "Community Park of Goshen" as the new name for the 11th County Park.


**FISCAL IMPACT/FINANCING:**
