AMENDMENT TO TULARE COUNTY AGREEMENT NO. PA3663

THIS AMENDMENT ("Amendment") to Tulare County Agreement Number PA3663 (the "Agreement") is entered into by and between the **COUNTY OF TULARE** ("COUNTY") and **RL Crawford Constructors, Inc.** ("CONTRACTOR") as of June 4, 2019, with reference to the following:

- A. The COUNTY and CONTRACTOR entered into the Agreement on January 8, 2019, for the purpose of providing construction services for the Tulare County Motor Pool Parts Office Project;
- B. COUNTY and CONTRACTOR now wish to further amend the Agreement in order to increase the agreement amount for the Tulare County Motor Pool Parts Office Project.

ACCORDINGLY, COUNTY and CONTRACTOR agree as follows:

1. Article 3 Paragraph 1: Contract Sum of the Agreement is hereby revised to read as follows:

In consideration of the covenants, agreements, and promises on the part of the CONTRACTOR contained in this Agreement, and the strict and literal fulfillment of each and every such covenant, agreement, and promise and as compensation in full for the performance and diligent completion of the work specified in Article (1) hereof, the County agrees to pay and cause to be paid to the CONTRACTOR according to the following schedule: One Hundred and Four Thousand Seven Hundred and Eighty Dollars and One Cent (\$104,780.01). It is mutually agreed that the COUNTY shall pay no more than a maximum of One Hundred and Four Thousand Seven Hundred and Eighty Dollars and One Cent (\$104,780.01) for the performance of all work under this contract.
