Approve an agreement with Vision y Compromiso

#### REQUEST(S):

That the Board of Supervisors:

- 1. Approve an agreement with Vision y Compromiso to deliver the National Diabetes Prevention Program, retroactive to July 1, 2018 through June 30, 2020 in the amount of \$47,875 This agreement is retroactive due to an inadvertent omission in submitting the agreement timely for processing and delays in negotiating terms in the agreement. It was impracticable for the Board to take action prior to July 1, 2018 due to the time needed to process, prepare, and submit the agenda item;
- 2. Find that the Board had the authority to enter into the proposed agreement as of July 1, 2018 and that it was in the County's best interest to enter into the agreement on that date; and
- 3. Authorize the Chairman of the Board to sign three (3) copies of the amendment.

#### **SUMMARY:**

In March 2015, the California Department of Public Health entered into Agreement No. 27264 with Tulare County Health and Human Services Agency to address uncontrolled and undiagnosed hypertension and prevent diabetes which have a significant impact on the health of Californians. The grant award period was from March 1, 2015 through September 29, 2018. The program's scope of work included

collaborating with a community partner to deliver the National Diabetes Prevention Program (NDPP). Vision y Compromiso was selected as the community partner to deliver NDPP services.

Vision y Compromiso has provided oversight and support to *promotoras de salud* (health promoters) as they engage communities on how to self-monitor blood pressure, connect with community-based organizations for additional resources, and deliver the National Diabetes Prevention Program (NDPP). As part of the Lifetime of Wellness grant, Vision y Compromiso deployed blood pressure monitors to all three County library systems, developed healthy store tours, and trained promotras as lifestyle coaches for the NDPP. Vision y Compromiso increased the use of these interventions and reached more than 300 participants.

Vision y Compromiso rendered services from October 2017 through September 2018 through Tulare County Professional Service Agreement No. 2762. These services were paid with Lifetime of Wellness grant funds. The vendor has been providing services from October 2018 until present without receiving payment. In addition, the Public Health Branch has determined it the best interest of the County to continue providing NDPP services through the continued collaboration with Vision y Compromiso. The Public Health Branch is requesting to continue the collaboration efforts by establishing an agreement through June 30, 2020. The cost associated with these services is \$47,875.

This agreement did not go through the Request For Proposal (RFP) process because it is for continuation of services.

The following term deviates from the standard County boilerplate: 1.) This agreement is contingent on funding.

#### FISCAL IMPACT/FINANCING:

This agreement is funded in part by a grant from the California Department of Public Health, with funding from the Centers for Disease Control, as well as the Public Health Branch. The agreement is in an amount not to exceed \$47,875. Of the total agreement amount, \$27,875 was budgeted in the 2018/2019 fiscal year. The remaining \$15,000 will be included in the fiscal year budget process for 2019/20 There is no net County cost to the General Fund.

#### LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic plan includes the Quality of Life initiative that encourages innovative provision of quality supportive services for at-risk adults, youth, and children in state and federally mandated programs. This agreement increases the ability to fulfill that commitment by providing healthy lifestyle education to adults with a high risk of developing diabetes.
