<u>SUBJECT</u>: Accept the Special Event Permit Application for the "Kasonno's Flat Bottom Boogie"

REQUEST(S):

That the Board of Supervisors:

- 1. Accept the Special Event Permit Application for the "Kasonno's Flat Bottom Boogie" to be held on Saturday, July 13, 2019, from 11:00 am to 3:00 pm at the Club Royal Oak RV Resort near the City of Kingsburg; and
- 2. Direct the Resource Management Agency Director, or designee, to consider the Special Event Permit Application.
- 3. Approve the "Kasonno's Flat Bottom Boogie" to be an on-going event for future years until such time as conditions of the event and/or the location change, and subject to submittals of complete application for each annual event.

SUMMARY:

The Resource Management Agency (RMA) received a Special Event Permit Application to hold the Kasonno's Flat Bottom Boogie event at the Club Royal Oak RV Resort near the City of Kingsburg. The event is sponsored and insured by Club Royal Oak. Prior to processing of the permit, the applicant must submit all required documentation for the Special Event Permit. Further, Tulare County Ordinance Code Section 2-05-1070 requires that Tulare County Sheriff approve the Special Event Permit prior to the issuance of the permit to the applicant for this activity. The Special Event Permit will not be issued until the Tulare County Sheriff is satisfied and the applicant has agreed to and signed the conditions required by the Tulare County Sheriff for the event.

SUBJECT: Accept the Special Event Permit Application for the "Kasonno's Flat Bottom Boogie" DATE: June 4, 2019

The Kasonno's Flat Bottom Boogie event offers professional drivers of flat-bottomed boats an opportunity to participate in a time trial exhibition.

Issuance of the Special Event Permit will grant Club Royal Oak authorization to conduct and manage the water-based activities of the event on permitted areas of Kings River.

In addition to the Special Event Permit, the land-based activities for the Kasonno's Flat Bottom Boogie event will require a Temporary Use Permit pursuant to Section 16.IV of the Tulare County Zoning Ordinance. The intent of this section is to provide for limited review and approval of short-term activities that would normally be prohibited in the zoning district for which the application is being made. Limited review will ensure compatibility with adjacent land uses availability of public services and infrastructure; thereby protecting the health, safety and welfare of the public. Temporary Use Permits are subject to approval by the Planning Director and may require the issuance of licenses, permits and/or clearances from other regulatory agencies.

No temporary road closures or traffic control will be required for this event.

FISCAL IMPACT/FINANCING:

No Net County Cost.

RMA will not incur cost as the event will be conducted and managed by Club Royal Oak, the sponsor of the event.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic plan includes the "Quality of Life" initiative to provide greater recreational and cultural opportunities.
