**SUBJECT:** Accept the Special Event Permit Application for the Pixley Union School District’s ASES 5K Run

- REQUEST(S):**  
That the Board of Supervisors:
1. Accept the Special Event Permit Application for the “Pixley Union School District’s ASES 5K Run” to be held on Saturday, June 8, 2019 from 8:00 am to 10:00 am in the unincorporated community of Pixley; and
  2. Approve the “Pixley Union School District’s ASES 5K Run” to be an on-going event for future years until such time as conditions of the event and/or the location change, and subject to submittals of complete application for each annual event.

**SUMMARY:**  
The Resource Management Agency (RMA) received a Special Event Permit Application to hold the Pixley Union School District’s ASES 5K Run event in the unincorporated community of Pixley. The event is sponsored and insured by the Pixley Union School District. Prior to processing of the permit, the applicant must submit all required documentation for the Special Event Permit.

The Pixley Union School District’s ASES 5K Run will be conducted and managed on County right-of-way by the Pixley Union School District. The route follows portions of the county roads shown in Attachment A. The event will commence in front of Pixley Middle School, then proceed west on Court Avenue to Walnut Street, then proceed south on Walnut Street to Terra Bella Avenue, then proceed east on Terra Bella Ave to Palm Road, then proceed north on Palm Road to Court Avenue, then west on Court

**SUBJECT:** Accept the Special Event Permit Application for the Pixley Union School District's ASES 5K Run

**DATE:** June 4, 2019

Avenue ending at the Pixley Middle School Track and Field.

Temporary road closures will be required for this event.

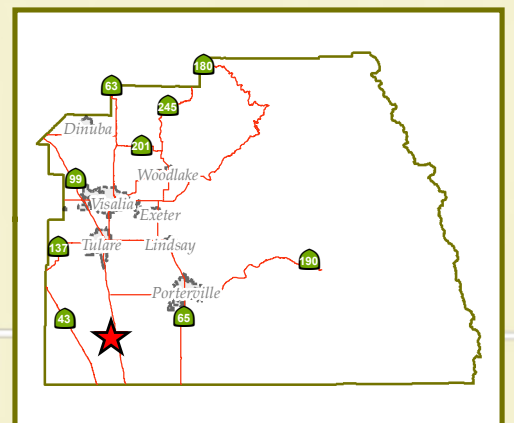
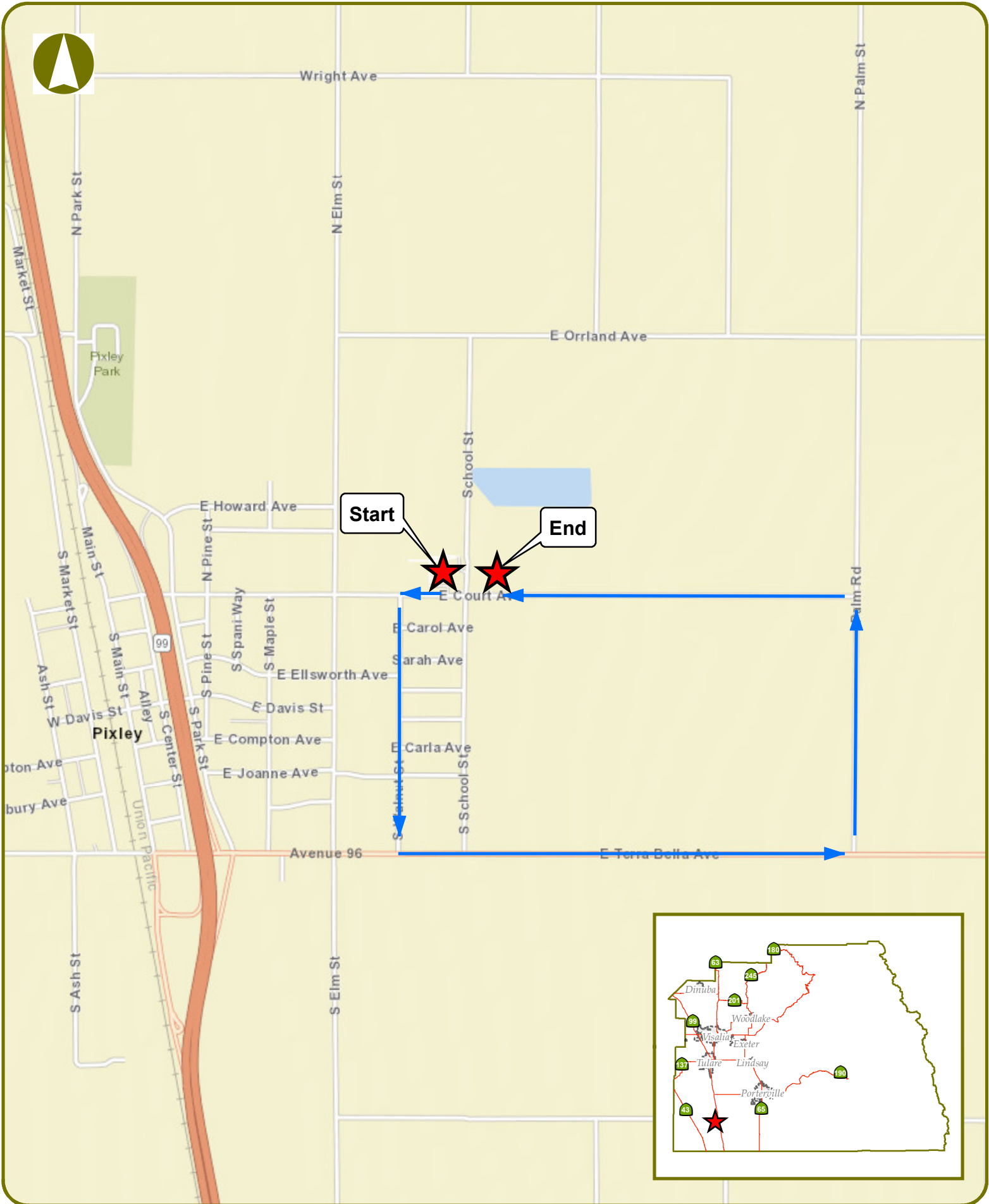
