SUBJECT: Accept the Special Event Permit Application for the “Jet Jam Racing Tour”

REQUEST(S):

That the Board of Supervisors:

1. Accept the Special Event Permit Application for the “Jet Jam Racing Tour” to be held on Saturday, June 8, 2019 and Sunday, June 9, 2019 from 7:00 am to 5:00 pm near the unincorporated community of East Porterville; and
2. Direct the Resource Management Agency Director, or designee, to consider the Special Event Permit Application.
3. Approve the “Jet Jam Racing Tour” to be an on-going event for future years until such time as conditions of the event and/or the location change, and subject to submittals of complete application for each annual event.

SUMMARY:

The Resource Management Agency (RMA) received a Special Event Permit Application to hold the Jet Jam Racing Tour event at Lake Success near the unincorporated community of East Porterville. The event is sponsored and insured by the Jet Jam Racing Inc. Prior to processing of the permit, the applicant must submit all required documentation for the Special Event Permit. Further, Tulare County Ordinance Code Section 2-05-1070 requires that Tulare County Sheriff approve the Special Event Permit prior to the issuance of the permit to the applicant for this activity.

This event offers riders an opportunity to operate their own personal jet skis in the designated jet ski permitted area at Success Lake and allow riders to participate in a

freestyle competition and surf racing.

Issuance of the Special Event Permit will grant Jet Jam Racing Inc. authorization to conduct and manage the water-based activities of the Jet Jam Racing Tour event at Lake Success.

All land-based activities for the Jet Jam Racing Tour event, including parking, will take place on U.S. Army Corps of Engineers (USACE) land and will have no impact on adjacent non-USACE lands. As such, a Temporary Use Permit will not be required for this event.

No temporary road closures or traffic control will be required for this event.

FISCAL IMPACT/FINANCING:

No Net County Cost.

RMA will not incur cost as the event will be conducted and managed by Jet Jam Racing Inc., the sponsor of the event.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic plan includes the "Quality of Life" initiative to provide greater recreational and cultural opportunities.

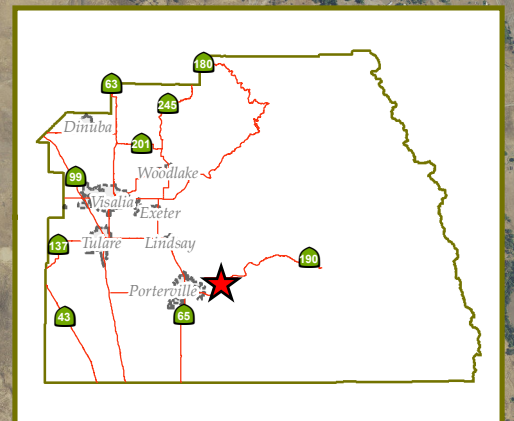
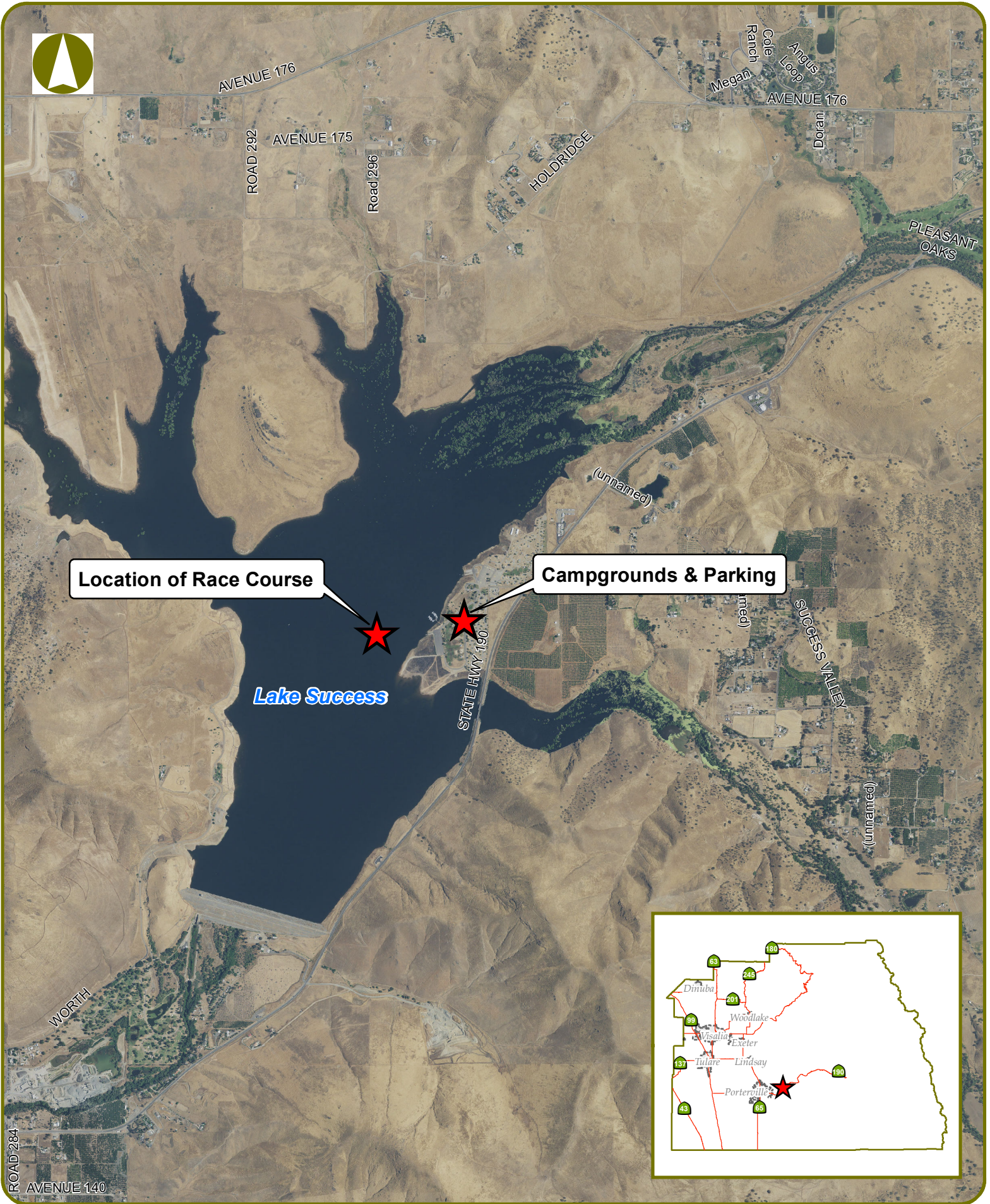
