SUBJECT: Approve an agreement with Tulare Youth Service Bureau, Inc.

REQUEST(S):

That the Board of Supervisors:

1. Approve an agreement with Tulare Youth Service Bureau, Inc. for an amount not to exceed \$5,500,000 for the provision of mental health services to Tulare County adolescents and children from July 1, 2019, through June 30, 2020; and
2. Authorize the Chairman of the Board to sign two (2) copies of the agreement.

SUMMARY:

To ensure a greater quality of life, Tulare Youth Service Bureau, Inc. (TYSB) provides specialty mental health services to children and adolescents located in Tulare County, under the administrative oversight of the Tulare County Health and Human Services Agency (HHSA), Mental Health Branch. These services include medication support, case management, group therapy, family therapy, rehabilitation, intensive home-based services and crisis intervention.

TYSB operates one clinic located in Tulare. It is estimated that over 1,863 unique consumers will utilize the services of TYSB through this agreement in Fiscal Year 2019/2020. Consumers can receive a wide array of services to meet their Mental Health needs. TYSB completes about 30,000 services a year; on average a single consumer will utilize 16 services within a single year. This agreement did not include a Request for Proposal process because TYSB has been providing quality services to children in Tulare County for more than twenty years. The County aims to continue contracting with this provider to maintain continuity of care and stability,

which is integral to children's mental health services. TYSB provides services that are mandated through Early and Period Screening, Diagnostic and Treatment.


FISCAL IMPACT/FINANCING:

The budgeted costs associated with this contract were included in the HHS 1221 budget, line 7052 medical providers, in an amount not to exceed \$5,500,000 and will be included in the Fiscal Year 2019/2020 budget. This agreement is paid with realignment and State Medi-Cal billing funds. There is no additional net cost to the County General Fund.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic plan includes the Quality of Life Initiative that encourages innovative provision of quality supportive services for at-risk adults, youth and children in state and federally mandated programs. This agreement increases the ability to fulfill that obligation by providing specialty mental health services to children and adolescents located in Tulare County.
