SUBJECT: Alpine Village-Sequoia Crest Community Services District

REQUEST(S):

That the Board of Supervisors:

Approve Alpine Village-Sequoia Crest Community Services District's request to continue with an annual financial compilation for the fiscal year ended June 30, 2019 (Unanimous vote required).

SUMMARY:

Per California Government Code Section 26909 (d) (1), a special district whose annual revenues do not exceed \$150,000 and has all of its revenues and expenditures transacted through the county's financial system "may, by annual unanimous request of the governing board of the special district and with annual unanimous approval of the board of supervisors, replace the annual audit required by this section with an annual financial compilation of the special district to be performed by the county auditor..." Resolution No. 2017-0396 authorized Alpine Village-Sequoia Crest Community Services District (the District) to replace their biennial audit with an annual financial compilation and an annual audit for the sixth year.

The statute provides that the county auditor performs the annual financial compilation, since the Tulare County Auditor-Controller's Office provides financial services, the District contracts with an outside auditor to do the annual financial compilation.

SUBJECT:Alpine Village-Sequoia Crest Community Services DistrictDATE:July 9, 2019

The first annual financial compilation under the approved resolution occurred for the Fiscal Year ended June 30, 2018. The District's Board unanimously agreed to continue with an annual financial compilation for the Fiscal Year ended June 30, 2019, as the second of five (5) consecutive years. The Tulare County Auditor-Controller's Office does not object to the request.

FISCAL IMPACT/FINANCING:

No impact on County costs.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic plan includes the Organizational Performance Initiative to provide for the stability of county operations through periods of economic fluctuations, changing priorities and service demands. By granting Alpine Village-Sequoia Crest Community Services District's request to continue with a financial compilation, it will help fulfill this initiative by allowing them to better serve their small district by incurring a lower administrative expense.
