SUBJECT: Approve an Agreement with the Pixley Union School District

REQUEST(S):

That the Board of Supervisors:

- Approve an Agreement with the Pixley Union School District in an amount not to exceed \$86,937, for the Sheriff's Office to provide School Resource Officer services on district campuses for the period of August 13, 2019 through June 3, 2020; and
- 2. Authorize the Chairman to sign three copies of the Agreement.

SUMMARY:

The Pixley Union School District is seeking to continue to partner with the Sheriff's Office to provide a Sheriff's deputy to serve as a school resource officer on district campuses.

Under the agreement, the deputy provides a visible law enforcement presence on campuses; assists school officials in enforcing school laws; utilizes intervention and prevention skills with students who are involved in criminal activity; acts as a resource deputy for school personnel; and provides classroom instruction on law enforcement issues such as gang awareness.

FISCAL IMPACT/FINANCING:

The Sheriff's Office will be compensated up to \$86,937 by the Pixley Union School District for the salary, benefits, and operating costs for the school resource officer. Funds are included in the Sheriff's Fiscal Year 2019/2020 budget. There is no net County cost to the General Fund.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's strategic plan includes the Safety and Security initiative. This agreement supports this initiative by collaborating with the school district to provide a visible deterrent at schools while having an immediate response if necessary.
