Background – CSA 1 & 2

- The following water and sewer systems are administered by Tulare County as Zones of Benefit within County Service Areas Nos. 1 & 2 and billed directly to service users:
 - Delft Colony Sewer
 - Delft Colony Water
 - El Rancho Sewer*
 - Seville Sewer
 - Tonyville Sewer
 - Tooleville Sewer

- Traver Sewer
- Wells Tract Water
- Wells Tract Sewer
- Yettem Sewer
- Yettem Water
- The County collects service fees to cover maintenance and operation costs.
- Some customers have failed to pay their service fees.
- Tulare County Ordinance 2924 (uncodified) authorizes the Board of Supervisors to place delinquent fees on the property tax roll in accordance with the provisions of the Health and Safety Code, Sections 5473 through 5474.10 and Government Code Section 6063.

^{*}El Rancho users are charged once a year on their property tax statement.



Background - Terra Bella

- Terra Bella Sewer Maintenance District (TBSMD) is administered by Tulare County and billed directly to service users.
- The County collects service fees to cover maintenance and operation costs.
- Some customers have failed to pay their service fees.
- The TBSMD Ordinance Number 3 (uncodified) allows the Board of Supervisors sitting as the Governing Board for the District, to place delinquent fees on property tax roll in accordance with the provisions of the Health and Safety Code, Sections 5470 through 5474.10 and Government Code Section 6063.



Background - Seville

- The Seville Water Company is administered by Tulare County as temporary court receiver since June 9, 2009 and bills directly to service users.
- The County collects service fees to cover maintenance and operation costs.
- Some customers have failed to pay their service fees.
- On June 28, 2011, the Board adopted Resolution Number 2011-048 (uncodified Ordinance Number 3428) allowing the placement of delinquent water fees for Seville Water Company on the property tax roll, in accordance with the provisions of Health and Safety Code Sections 5470 to 5474.10 and Government Code 6063.



Timeline

- April 30, 2019 Customers with balance were mailed notices
- May 31, 2019 Customers with outstanding balance were mailed notices (2nd notice)
- June 28, 2019 Final notice (3rd) customers with outstanding balances
- July 3, 2019 First publication of notice of Delinquent Accounts published
- July 10, 2019 Second publication of notice of Delinquent Accounts published
- July 17, 2019 Third publication of notice of Delinquent Accounts published
- July 23, 2019 Board of Supervisors conducts Public Hearing
- July 31, 2019 Payment deadline is at 4:30 P.M.
- August 12, 2019 Delinquent customer list due to Auditor's Office for placement on Tax Roll

Requests

- 1. Conduct a Public Hearing on July 23, 2019, at 9:30 a.m. or as soon thereafter as can be heard in the Board Chambers, Administration Building, 2800 West Burrel, Visalia, California, to consider placement of delinquent water and sewer service fees, delinquent penalties, and Auditor's collection charges for County Service Areas No. 1 and No. 2, Terra Bella Sewer Maintenance District and Seville Water Company on the 2019/2020 tax roll; and
- 2. Direct the Auditor/Tax Collector to place delinquent sewer and water service fees, delinquent penalties, and the Auditor's collection charges of County Service Areas No. 1 and No. 2 (Exhibits A-J), Terra Bella Sewer Maintenance District (Exhibit A) and Seville Water Company (Exhibit A) customers on the 2019/2020 tax roll if still delinquent after July 31, 2019.
