Approve an agreement with Kings View Corporation

#### REQUEST(S):

That the Board of Supervisors:

- Approve an agreement with Kings View Corporation to allow Tulare County Health and Human Services Agency (HHSA) to collect a monitoring fee of 4.5% for the purposes of the Tulare County Driving Under the Influence (DUI) Program effective from July 30, 2019 until either party terminates; and
- 2. Authorize the Chairman of the Board to sign two (2) copies of the agreement.

#### SUMMARY:

Through this agreement, the Tulare County HHSA, Mental Health Branch, will collect a four and a half percent (4.5%) monitoring fee from Kings View Corporation for the maintenance of a DUI Program within Tulare County. This is pursuant to the State of California Motor Vehicle Code which mandates that those arrested while driving under the influence of alcohol and/or drugs be sent to an early intervention program.

Kings View Corporation operates a program that incorporates counseling, monitoring, and education in an attempt to decrease the number of substance abuse related vehicle accidents and deaths. Kings View Corporation provides a multi-component early intervention program. The length of the program is dependent on the Blood Alcohol Content of the offender at the time of arrest and whether they have received a DUI within the previous ten (10) years. This program is operated under the regulations of the State of California Department of Health Care Services (DHCS) as outlined in Title 9 of the Administrative Code. It is

projected that over 800 participants will be served through this agreement.

On June 18, 2019 the Board of Supervisors approved a letter of recommendation for Kings View, Corporation to be Tulare County's DUI provider and to apply with DHCS for licensure for the Tulare County DUI Program.

The following term deviates from standard County boilerplate: This agreement has no terminate date.

### FISCAL IMPACT/FINANCING:

Participants are required to pay Kings View Corporation for the cost of the program. Kings View Corporation will pay the HHSA Mental Health Branch a monitoring fee of 4.5% of the fees collected. The amount of revenue generated by this agreement will depend on the number of participants in the programs. Anticipated revenue in the amount of \$40,000 will be included in Fiscal Year 2019/2020 budget based on historical levels. There is no cost associated with this agreement and no net County cost to the General Fund.

## LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic plan includes the Safety and Security Initiative that provides facilities and resources for training and rehabilitation of criminal offenders. This agreement increases the ability to fulfill that obligation by providing oversight of a program that incorporates counseling, monitoring, and education, in an attempt to decrease the number of substance abuse related vehicle accidents and deaths.
