SUBJECT: Approval of Parking Restrictions on Three Road Locations

REQUEST(S):

That the Board of Supervisors:

- Approve the designation of a parking restriction by the installation of "No Parking" signs and to establish a "No Parking" zone by painting the curb red on the southwest corner on Court Avenue (A100) and Spani Way (LR126A), in Pixley;
- 2. Approve the designation of a parking restriction by the installation of "No Parking" signs and to establish a "No Parking" zone by painting the curb red on the south side of Avenue 196 just west of Road 228, in Strathmore;
- Approve the designation of a parking restriction by the installation of "No Stopping" signs and to establish a "No Stopping" zone by painting the curb red on both sides of Road 124 just south of Avenue 413, in Orosi;
- Authorize the installation of "No Parking" signs and by painting the curb red on the southwest corner on Court Avenue (A100) and Spani Way (LR126A), in Pixley;
- 5. Authorize the installation of "No Parking" signs and by painting the curb red on the south side of Avenue 196 just west of Road 228, in Strathmore;
- 6. Authorize the installation of "No Stopping" signs and by painting the curb red on both sides of Road 124 just south of Avenue 413, in Orosi;

7. Approve the Categorical Exemptions consistent with the California Environmental Quality Act (CEQA) Title 14 California Code of Regulations (CCR), Section 15061(b)(3) Common Sense Exemption;

- 8. Find there is no substantial evidence that proposed activity will have a significant effect on the environment and determine the Categorical Exemptions are consistent with the CEQA Title 14 CCR, Section 15061(b)(3) Common Sense Exemption, that was prepared for the project reflects the independent judgment of the County and completed in compliance with the CEQA of 1970; and
- 9. Direct the Environmental Assessment Officer of the Tulare County Resource Management Agency, or designee, to file the Notice of Exemptions with the Tulare County Clerk.

SUMMARY:

Tulare County Resource Management Agency (RMA) has been performing road improvement projects countywide. Two of the three requests for parking restrictions are the result of these projects. The remaining request for parking restrictions is due to a constituent request to improve pedestrian safety.

Location 1: Court Avenue (A100) and Spani Way (LR126A), in Pixley

The intersection of Court Avenue at Spani Way is located in the community of Pixley. Recent improvements to Court Avenue included the establishment of designated bike lanes along the roadway and in front of the middle and elementary school. After the installation of the pavement striping on Court Avenue to transition the existing to the newly constructed roadway, it was determined that there was inadequate roadway width to accommodate both through traffic and curbside parking on the southwest corner on Court Street at Spani Way (LR126A). Therefore, staff recommends the installation of a "No Parking" sign and establishing a "No Parking" zone by painting approximately 62 feet of curb red located on the south side of Court Avenue, west of Spani Drive.

Location 2: Avenue 196 just west of Road 228, in Strathmore

The intersection of Avenue 196 at Road 228 is located in the community of Strathmore. Strathmore High School is located at the southwest corner of this intersection. Improvements to this intersection will include curb, gutter, sidewalks, ADA compliant ramps and crosswalks. These improvements will provide a safe route for students to walk to and from the high school. As a result of these improvements, it was determined that "No Parking" restrictions installed on the southwest corner of this intersection will provide improved sight visibility for northbound traffic stopped on Road 228. Therefore, staff recommends the installation of "No Parking" signs and establishing a "No Parking" zone by painting approximately 200 feet of curb red on the southwest corner on Avenue 196 at Road 228.

SUBJECT: Approval of Parking Restrictions on Three Road Locations

DATE: August 13, 2019

Location 3: Road 124 just south of Avenue 413, in Orosi

This site is located on Road 124, south of Avenue 413 in the community of Orosi. This location is adjacent to the Orosi Swap meet. The swap meet is located on the east side and the parking lot is located on the west side of Road 124. Due to concerns for the safety of pedestrians crossing Road 124 during operating hours of the swap meet, the owners of the swap meet contacted RMA. Staff met with the owner and determined the installation of new ADA ramps (paid for by the owner), and the installation of crosswalks and red painted curbing by the county would address pedestrian safety. Therefore, staff recommends the installation of "No Stopping" signs on both side of Road 124 and establish a "No Stopping" zone on Road 124, south of Avenue 413, by painting 50 feet of curb on the east side and 60 feet on the west side of Road 124.

Once this request is approved, these locations will be added to the master list (See Attachment E) for parking restrictions, which is kept by Tulare County RMA. Formally adopting these locations and restrictions will ensure that the parking ordinance is enforceable.

FISCAL IMPACT/FINANCING:

No Net County Cost to the General Fund.

The cost of installing these parking restrictions is budgeted in the current fiscal year's Roads Budget for signs and stenciling.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

Strategic Initiative: Safety and security includes the goal of improving and maintaining adequate transportation infrastructure. Designation of the "No Parking" and "No Stopping" zones along with sign installation at these three locations will enhance intersection circulation and safety.






