SUBJECT: Naming of the South County Detention Facility and Dedication Plaque

REQUEST(S):

That the Board of Supervisors:

1. Approve "South County Detention Facility" as the name for the newly constructed 510-bed jail located in Porterville in accordance with County Administrative Regulation No. 12.
2. Approve the design of the proposed dedication plaque to be installed at the South County Detention Facility.

SUMMARY:

On August 13, 2019, the Board accepted the South County Detention Facility (SCDF), as a completed project. In accordance with Administrative Regulation No. 12, Revision No. 1 (AR-12), established by Resolution No. 96-0388, staff are requesting to formalize the name of the facility and design of the dedication plaque.

The proposed name for the facility is the "South County Detention Facility", as was previously described in various plans, documents, and agenda items for the last several years. The design of the plaque features the month and year of dedication, the County seal, and the names of the following: the facility, the Board of Supervisors at the time of dedication, the County Administrative Officer, the Tulare County Sheriff, the architecture firm, the general contractor, and the construction management firm.

The design proposes one-inch, bold, sanserif font on a 24" x 30" cast bronze or aluminum plaque. A draft of the proposed layout may be found in Attachment A.


FISCAL IMPACT/FINANCING:
