

**FIRST AMENDMENT TO
TULARE COUNTY AGREEMENT NO. 28624**

THIS FIRST AMENDMENT ("Amendment") to Tulare County Agreement Number 28624 (the "Agreement") is entered into by and between the **COUNTY OF TULARE** ("COUNTY") and **Star View Behavioral, Inc., a wholly owned subsidiary of Stars Behavioral Health Group Holding Company, Inc.**, ("CONTRACTOR") as of _____, with reference to the following:

A. The COUNTY and CONTRACTOR entered into Agreement Number 28624 on July 1, 2018, for the purpose of providing psychiatric beds in the Community Treatment Facility (CTF) and Psychiatric Health Facility (PHF). The CTF and PHF also provide specialty mental health treatment modalities including: Day Treatment Intensive, Medication Support, Mental Health Services, Therapeutic Behavioral Services, Case Management Services, and Crisis Intervention Services; and

B. COUNTY and CONTRACTOR now wish to amend the Agreement in order to add a supplemental fee per bed day for both Community Treatment Facility and Psychiatric Health Facility, for the provision of residential treatment and Mental Health services and placed on youth presumptive transfer. The presumptive transfer acts as a transfer of responsibility for the youth to another county to provide services. Additionally, update Exhibit B-1.

ACCORDINGLY, COUNTY and CONTRACTOR agree as follows:

1. This First Amendment becomes effective as of August 1, 2018.
2. Exhibit B-1 is hereby replaced with the attached Exhibit B-1 to reflect the addition of the supplemental fee per bed day for both Community Treatment Facility and Psychiatric Health Facility, for the provision of residential treatment and mental health services placed on youth presumptive transfer
3. Except as provided above, all other terms and conditions of the Agreement shall remain in full force and effect.





RATE SCHEDULE
Fiscal Year 2018/2019

County of Tulare County
Mental Health Agreement

The daily rate is all inclusive for services as defined as psychiatric inpatient services in Title 9, Chapter 11, Section 1810.430 (d) (5), and that rate does not include non-hospital-based physician or psychological services rendered to a beneficiary covered under the contract. The day of discharge is non-reimbursable.

The rates for the term of this Agreement, unless otherwise amended and agreed to by both parties in writing are:

1. Psychiatric Health Facility (PHF): \$807.39/day
2. Psychiatric Health Facility (PHF) Administrative Day: \$807.39/day
3. Community Treatment Facility (CTF)
 - Day Treatment Intensive: \$251.02/ day
 - Medication Support: \$5.97/minute
 - Mental Health Services: \$3.23/minute
 - Case Management Services: \$2.50/minute
 - Crisis Intervention Services: \$4.73/minute
 - Therapeutic Behavior Services: \$3.23/minute

The rates to the County Mental Health Branch for CTF mental health supplement are:

1. CTF mental health supplement: \$75.00/day
2. CTF Supplement: \$82.19 (\$2,500.00/month) - [this can be claimed to SDHCS for offset of CTF costs- approximately \$32.00/day reimbursement from SDHCS]

For any child authorized under Presumptive Transfer (Prompt transfer of the responsibility for the provision of services, or arrange and payment for specialty mental health services from the count of original jurisdiction to the county in which the youth resides), the County shall also reimburse Contractor an additional \$90 supplemental fee per bed per day for both the PHF and CTF for Fiscal Year 2018/2019 and \$92.88 for Fiscal Year 2019/2020.
