#### REQUEST(S):

That the Board of Supervisors:

- 1. Approve and award the contract to the lowest responsive and responsible bidder, American Paving Co. from Fresno, California, in the amount of \$483,990.60 for construction of the Earlimart Park Sidewalk Improvements Project; and
- Authorize the Chairman to sign the contract after review and approval as to form by County Counsel and upon receipt of certificates of insurance, bonds and evidence that the contractor possesses a valid State Contractors License; and
- 3. Waive the clerical error that was identified in the lowest bid and accept the correction submitted by the lowest responsive and responsible bidder; and
- 4. Allow funds for contingencies in the amount \$36,700 to cover unexpected construction conditions; and
- 5. Authorize the Director of the Resource Management Agency or his designee to approve contract change orders up to the amount of allowed funds for contingencies.

**DATE:** September 10, 2019

#### **SUMMARY:**

The Earlimart Park Sidewalk Improvements Project (the Project) will improve accessibility around Earlimart Park and Earlimart Elementary School by constructing sidewalk, ADA ramps, driveways, curb and gutter, drainage infrastructure, and asphalt paveouts. The Project limits are along Church Street from approximately Clay Avenue south to School Avenue, then along School Avenue from Church Avenue to Elm Street, then along Elm Street from School Avenue to approximately Cannon Avenue. The sidewalk project will complete the section of curb gutter and sidewalk around the recently completed Earlimart Park.

This project was programmed in the 2018/2019 County Transportation Improvement Program (18/19 CTIP) for project initiation. Partial funding through the ATP was awarded through a highly competitive selection process.

#### **Construction Bids**

The Project was authorized to bid by the Board of Supervisors (Resolution No. 2019-0605) on July 9, 2019. Bids were opened on August 15, 2019 and six (6) bids were received, summarized as follows:

The lowest bid in the amount of \$483,990.60 was submitted by American Paving Co. of Fresno, CA. This bid is approximately \$117,010 lower than the Engineer's Estimate. There was a clerical error identified on one of the Exhibit 15-G Local Agency Bidder DBE Commitment (Construction Contracts) forms submitted by the lowest bidder. The incorrect bid items numbers were listed under column 10 "Bid Item Number" for two of the items. The error was deemed inconsequential, as it does not materially affect the bid, or otherwise result in an unfair advantage to the lowest bidder. A corrected form was submitted by the lowest responsible and responsive bidder.

Based on the information mentioned above, it is Resource Management Agency staff's recommendation that the Board award the contract to American Paving Co., the lowest responsive and responsible bidder. American Paving Co. has satisfactorily performed similar projects, where they demonstrated that they (1) have adequate financial resources to perform the contract, (2) are able to comply with the associated legal or regulatory requirements, (3) have or can obtain necessary data, equipment,

and facilities, and (4) is otherwise eligible and qualified to receive award.

Construction is anticipated to begin in October 2019.
