SUBJECT:

Approve an Agreement with the United States Department of

Justice

REQUEST(S):

That the Board of Supervisors:

- 1. Ratify and approve an agreement with United States Department of Justice to provide investigator assistance in an amount not to exceed \$25,000, retroactive to August 1, 2019 to September 30, 2019. The agreement is retroactive due to the timing of the receipt of the documentation from the United States Department of Justice. It was impracticable for the Board to take action prior to August 1, 2019 due to the time needed to process, prepare, and submit the agreement and agenda item;
- Find that the Board had authority to enter into the proposed agreement as
 of August 1, 2019, and that it was in the County's best interest to enter
 into the agreement on that date;
- 3. Ratify the Chairman's signature on the agreement; and
- Approve the necessary budget adjustments per the attached AUD 308 (4/5ths vote required).

SUMMARY:

This agreement with the United Stated Department of Justice provides \$25,000 in overtime funding to the Sheriff's Office for its investigators to assist the United States Department of Justice, Drug Enforcement Administration, Organized Crime

SUBJECT: Approve an Agreement with the United States Department of Justice

DATE: September 10, 2019

Drug Enforcement Task Force investigations (OCDETF). Sheriff's Office investigators will assist OCDETF in various tasks associated with the criminal investigation, under the direction of a Sheriff's supervisor. These additional OCDETF investigative tasks will not interfere with or delay the assigned investigations already assigned to the Sheriff's Office.

This Agreement deviates substantively from the County's standard boilerplate in the following ways: 1) The County signs the agreement first; and 2) Either party may terminate the agreement with (10) ten days prior written notice.

FISCAL IMPACT/FINANCING:

The United States Department of Justice will fund the Sheriff's Office in an amount not to exceed \$25,000 to defray the overtime costs for Sheriff law enforcement personnel for the agreement period of August 1, 2019 to September 30, 2019. The agreement funding was not included in the Sheriff's Office Fiscal Year 2019/20 operational budget, and an AUD 308 is required to increase the Sheriff's Office revenue and expense appropriations. There is no additional net County cost to the General Fund.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year Strategic Business Plan and Management System include Safety and Security initiatives to provide for the safety and security of the public. This agreement will fulfill this initiative by allowing the Sheriff's Office to provide investigators to assist the U.S. Department of Justice in an investigation.
