

1 **FIRST AMENDMENT TO AGREEMENT A-04-104**

2 THIS FIRST AMENDMENT TO AGREEMENT (hereinafter "Amendment") is made and entered
3 into this _____ day of _____, 2019, by and between COUNTY OF FRESNO, a Political
4 Subdivision of the State of California, Fresno, California (hereinafter "FRESNO"), and COUNTY OF
5 TULARE, a political subdivision of the State of California, whose address is 2800 W Burrel Avenue,
6 Visalia, California, (hereinafter "TULARE").

7 **WITNESSETH:**

8 WHEREAS, COUNTY and CONTRACTOR entered into Agreement number A-04-104, dated
9 16TH day of March, 2004 (hereinafter "Agreement"), pursuant to which FRESNO agreed to provide
10 Emergency Medical Services Agency Administration to TULARE; and

11 WHEREAS, COUNTY and CONTRACTOR now desire to amend the Agreement in order to
12 modify compensation terms.

13 NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which
14 is hereby acknowledged, COUNTY and CONTRACTOR agree as follows:

15 1. Section F ("COMPENSATION") of the Agreement, beginning on page 15, line 10
16 through page 16, line 16, is deleted in its entirety and replaced with the following:

17 "Effective July 1, 2019, compensation paid by TULARE to FRESNO under this
18 AGREEMENT for the provision of services hereunder shall be at a rate of FIFTY-THREE THOUSAND
19 EIGHT HUNDRED SEVENTY FOUR DOLLARS AND 60/100 (\$53,874.60) annually."

20 COUNTY and CONTRACTOR agree that this Amendment is sufficient to amend the
21 Agreement and, that upon execution of this Amendment, the Agreement and this Amendment together
22 shall be considered the Agreement.

23 The Agreement, as hereby amended, is ratified and continued. All provisions, terms,
24 covenants, conditions and promises contained in the Agreement and not amended herein shall remain
25 in full force and effect.
