SUBJECT:

Approve an Agreement with the PAAR Center

REQUEST(S):

That the Board of Supervisors:

- 1. Approve an Agreement with the PAAR Center in an amount not to exceed \$350,000, to provide offenders recently realigned under Assembly Bill (AB) 109 with residential treatment, training services, and outpatient services, retroactive from July 1, 2019 through June 30, 2020. This Agreement is retroactive due inadvertent delays in obtaining signatures. It was impractical for the Board to take action prior to July 1, 2019 due to time needed to process, prepare, and submit the Agenda Item;
- Find that the Board had the authority to enter into the proposed Agreement as of July 1, 2019, and that it was in the County's best interest to enter into the Agreement on that date; and
- 3. Authorize the Chairman to sign three (3) copies of the Agreement.

SUMMARY:

The PAAR Center is a non-profit, community-based facility that provides residential and out-patient substance abuse treatment for adult felony offenders. Referrals include individuals subject to Post-Release Community Supervision, in addition to

individuals placed on Mandatory Supervision or Formal Probation pursuant to Sections 1170(h) and 1203 of the Penal Code. The PAAR Center is committed to providing treatment and case management services in an effort to break the course of addiction, improve the quality of lives, and reduce recidivism.

The Probation Department has an established relationship with the PAAR Center, who have received referrals and provided treatment interventions to adult offenders since October 10, 2011.

This Agreement does not substantively deviate from the standard County Boilerplate.

FISCAL IMPACT / FINANCING:

The Agreement cost for services from July 1, 2019 through June 30, 2020 with the PAAR Center is in an amount not to exceed \$350,000, which will be included in the Probation Department's FY 2019/2020 budget. The costs associated with the Agreement are offset by revenue received from Senate Bill (SB) 678 and AB 109. There are no net County costs to the General Fund.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic business plan includes the Safety and Security initiative that provides for the safety and security of the public. The approval of this agreement helps fulfill this initiative by contracting with the PAAR Center for community-based treatment services designed to improve the quality of lives and reduce recidivism.
