REQUEST(S):

That the Board of Supervisors:

- 1. Approve an Amendment to Agreement No. 29066 with Serban's Background Music, Inc. to increase the agreement amount by \$2,805.84 from \$432,949 to \$435,754.84.
- 2. Accept the work for installation of the Board Chambers Technology Upgrade as complete by Serban's Background Music, Inc.
- 3. Authorize the Chairman to sign the Amendment and Notice of Completion.
- 4. Direct the Clerk of the Board of Supervisors to record the Notice of Completion for the project with the office of the Tulare County Recorder.

SUMMARY:

On March 19, 2019, the Board approved Agreement No. 29066 with Serban's Background Music, Inc. to provide technology upgrades for the aging audiovisual, multimedia, and room control systems within the Board Chambers. The Project resulted in a high quality, high definition, state-of-the-art audiovisual and room control system to facilitate and document the County's Board of Supervisors meetings, voting records, and presentations - the recording of which will be made available on the internet. Moreover, the project provided high definition, high performance, professional digital multimedia and broadcast systems capable of meeting the County's current and future audiovisual and room control technology needs.

For Change Order No. 1, there is one (1) proposed change order (PCO) that has been accepted. The following is a summary of the PCO:

The Board chambers technology upgrade was closely monitored by County staff including the Clerk of the Board, Information, Communications, and Technology, and Capital Projects. The project has been completed in accordance with the project specifications and is ready for acceptance by the Board.
