SUBJECT: Approve an agreement with the U.S. Department of Justice

REQUEST(S):

That the Board of Supervisors:

- 1. Approve an award from the U.S. Department of Justice in an amount not to exceed \$516,434 for participation in the State Criminal Alien Assistance Program, for the period of July 1, 2017 through June 30, 2018; and
- Approve the necessary budget adjustments per the attached AUD 308 (4/5ths vote required).

SUMMARY:

The U.S. Department of Justice (USDOJ) State Criminal Alien Assistance Program (SCAAP) has an annual reimbursement program. Under SCAAP, the USDOJ reimburses States and units of local government that incur costs due to incarceration of undocumented criminal aliens during a particular 12-month reporting period. The reporting period of this application was July 1, 2017 through June 30, 2018.

On May 21, 2019, your Board authorized the Sheriff's Office to submit an online reimbursement application to the USDOJ, Resolution No. 2019-0410. The Sheriff's Office was awarded the reimbursement in the amount of \$516,434. USDOJ does not provide an award agreement, awardee's drawdown the funds as one electronic transfer to the awardees bank account.

The financial reimbursement is a partial reimbursement and does not reimburse the Sheriff's Office for all cost for criminal alien incarceration incurred during the request

period. The County received \$608,907 reimbursement from the FY 16/17 SCAAP allocation, which covered the period July 1, 2016 through June 30, 2017. This amount was based on the daily rate of reimbursement, which is calculated after SCAAP receives its funding allocation and the analysis of applications received from other agencies. The financial reimbursement allocation to States and units of local government varies each reporting period.

FISCAL IMPACT/FINANCING:

The USDOJ awarded the Sheriff's Office a total amount not to exceed \$516,434 for SCAAP reimbursement. In Fiscal Year 2019/20, the Sheriff's Office budgeted \$250,000 for grant revenue and expenses. The attached AUD 308 budget adjustment will increase the appropriations for expense and revenue for the remaining \$266,434 of the grant award in the Sheriff's Office operational budget. There is no additional net County cost to the General Fund.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic plan includes the Safety and Security Initiative. The agreement will help fulfill this initiative by providing partial reimbursement costs for individuals incarcerated in Tulare County detention facilities. These funds supplement detention costs, allowing the Sheriff's Office to continue providing inmate programs and other resources needed to ensure the safety of the inmates and community.
