**SUBJECT**: Approve the Final Map for Subdivision Tract No. TSM 17-001

#### REQUEST(S):

That the Board of Supervisors:

- Approve the Final Map for Tract No. TSM 17-001, located on the west side of Road 132, approximately 250 feet south of Avenue 232, east of the City of Tulare; and
- 2. Accept the dedication of right of way as shown on the Final Map.

#### **SUMMARY:**

The subdivider for the Final Map of TSM 17-001 is Todd Homes. The tentative map was conditionally approved by the Planning Commission on January 24, 2018. Subdivision TSM 17-001 is a division of 11.52 acres comprised of three parcels into six parcels located on the west side of Road 132, approximately 250 south of Avenue 232 (State Highway 137) east of the City of Tulare.

The required improvements for the subdivision were subject to plan approval and inspection by the Resource Management Agency Public Works Branch. The improvements were completed before the recordation of the final map.

Ten percent of the total estimated construction costs in the form an instrument of credit will be retained by the county for a period of one year following approval of the final map as a guarantee and warranty against defective work or materials furnished pursuant to Section 7-01-2045 of the ordinance code.

The County Surveyor has determined that the Final Map of Subdivision Tract No. TSM 17-001 is in conformance with the Subdivision Map Act, local ordinances and

conditions of Tentative Map approval applicable at the time of filing. State law requires the local legislative body to approve a final map if it conforms to the requirements of the Subdivision Map Act and local ordinance. Therefore, in the absence of evidence of noncompliance, the County is obligated to approve the Final Map for Tract No. TSM 17-001.

#### FISCAL IMPACT/FINANCING:

There is no net county cost to the general fund. The subdivider has borne the cost of the required improvements.




