REQUEST(S):

That the Board of Supervisors:

- 1. Accept the work for the construction of the Worth Drive (M146) Safety Improvements Project (Porterville) as complete by Safety Striping Service, Inc. of Goshen, California; and
- 2. Authorize the Chairman to sign the Notice of Completion; and
- 3. Direct the Clerk of the Board to have the Notice of Completion recorded with the County Recorder.

SUMMARY:

This Notice of Completion is for the construction of the Worth Drive (M146) Safety Improvements Project. This project was completed on schedule and within the allowable budget. The work was performed by Safety Striping Service, Inc. under Tulare County Agreement No. 29153.

This project was approved by your Board on February 26, 2019. The lowest responsible bid was submitted by Safety Striping Service, Inc. On May 21, 2019, your Board awarded and approved a contract (Resolution No. 2019-0398) to Safety Striping Service, Inc. of Goshen, California in the amount of \$198,980.

This project improved the safety of a 1.0-mile stretch of Worth Drive (M146) between Road 278 and Road 284 by installing centerline rumble strips along the corridor. Improvements also included replacing existing signs and replacing the existing striping with a 6-inch-wide stripe.

There was one Contract Change Order (CCO) for this project with a net total cost of zero dollars written to allow contract items to exceed the 125% threshold without the need to provide an adjustment to the contract item unit price.

This project has been completed in accordance with the plans and specifications and is now ready for acceptance by the Board.

An allowance of 10% of the contract bid amount, or \$19,898, was authorized for contingencies at the time of award setting the total approved contract amount at \$218,878.

The final cost to complete this project was \$201,960 which is 1.50% above the bid amount and is 7.73% below the authorized contract amount plus contingencies.

This project was funded through the Highway Safety Improvement Program (HSIP) and Road Funds.


