#### REQUEST(S):

That the Board of Supervisors:

- Approve an amendment to Agreement No. 29249 with Turning Point of Central California, Inc. for the North County One-Stop Center to include Exhibit B-5, the Interim Reimbursement Rate Schedule, retroactive from July 1, 2019 through June 30, 2020. This amendment is retroactive, as Exhibit B-5 was inadvertently not included in the original agreement, making it impracticable for the Board to take action prior to July 1, 2019;
- Find that the Board had authority to enter into the proposed amendment as of July 1, 2019, and that it was in the County's best interest to enter into the amendment on that date; and
- 3. Authorize the Chairman of the Board to sign two (2) copies of the amendment.

#### SUMMARY:

The Tulare County Health and Human Services Agency (HHSA), Mental Health Branch, collaborates with Turning Point of Central California, Inc. to provide mental health services through the North County One-Stop Center under the Mental Health Services Act (MHSA), Community Services and Supports component. Turning Point of Central California, Inc. North County One-Stop Center is designed to offer a wide array of integrated services to youth ages 12 to 15 years and transitional age youth ages 16 to 25 years. Stop Center program employs a Children's System of Care Model that promotes the integration of mental health services and quality of life approaches such as employment, education, drug/alcohol counseling, and life skills training. During the year, the program will provide services to 180 unduplicated consumers in addition to participating in community outreach and engagement opportunities.

The County and Turning Point of Central California, Inc. entered into Agreement No. 29249 on June 25, 2019 and are now requesting to amend the agreement to include Exhibit B-5, the Interim Reimbursement Rate Schedule for Fiscal Year 2019-2020. This rate schedule is intended to approximate the Medi-Cal costs incurred by Contract providers for services rendered to Medi-Cal beneficiaries. Final reimbursement shall be the lower of cost or the Interim Reimbursement Rate, subject to all Title XIX Short-Doyle/Medi-Cal requirements. Exhibit B-5 was inadvertently omitted from the original agreement.

This contract does not deviate from the standard County boilerplate.

#### FISCAL IMPACT/FINANCING:

The budgeted costs associated with this contract are included in the HHSA 3331 budget, line 7052 medical providers, in the amount not to exceed \$700,000 and was included in the Fiscal Year 2019-2020 budget submission. The average estimated cost per consumer is \$4,761 based on Fiscal Year 2018-2019. The estimated amount is subject to change based on actual utilization. There is no fiscal impact with approval of this amendment. These services are paid through State Medi-Cal reimbursement and MHSA revenues. There is no fiscal impact with approval of this amendment. There is no additional net cost to the County General Fund.

### LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic plan includes the Quality of Life Initiative to promote and encourage the provision of quality supportive services for individuals in Tulare County. Turning Point of Central California, Inc. North County One-Stop Center will benefit the residents of Tulare County by providing mental health services that promote health and well-being to the youth and transitional aged youth so that they become independent adults and productive members of society.
