REQUEST(S):

That the Board of Supervisors:

Acknowledge the Certified Statement of Vote, as submitted by the Registrar of Voters, for the November 5, 2019 Uniform District Election Law (UDEL) Election.

SUMMARY:

On November 5, 2019, the Registrar of Voters conducted the Uniform District Election Law Election. There was one Mail Ballot precinct. After the Official Canvass of an election is complete and per Elections Code 15372, the Registrar of Voters is required to prepare a certified statement of the results of the election and submit it to the governing body within thirty (30) days of the election. Therefore, the Certified Statement of Vote was submitted to the Ponderosa Community Services District. The Registrar of Voters is also required to post the certified statement of results on their internet website.

The Certified Statement of Vote shall include the following:

1. Total number of ballots cast.
2. The number of votes cast at the precinct for each candidate.

The Registrar of Voters processed a total of 23 ballots for the election with 6 votes for Frank B. Ohnesorgen and 17 votes for Beth Benton. There are 32 registered voters in the Ponderosa Community Services District. The ballots counted were all mail Precinct ballots.
