**SUBJECT:** Approve the Distribution of Assembly Bill 109 Funding

**REQUEST(S):**

That the Board of Supervisors:

1. Approve the distribution of Assembly Bill 109 Base Funding estimated at \$19,580,361 for FY 2019/2020;
2. Approve the distribution of ninety-percent (\$954,018.90) of the total FY 2018/2019 Assembly Bill 109 Growth Funding of \$1,060,021, which is divided equally between the Sheriff's Office (\$477,009.45) and Probation Department (\$477,009.45) to fund continued implementation of criminal justice realignment in Tulare County; and
3. Approve ten-percent (\$106,002.10) of the total FY 2018/2019 Assembly Bill 109 Growth Funding of \$1,060,021 to remain in the Local Innovation Fund.

**SUMMARY:**

In an effort to address overcrowding in California's prisons and assist in alleviating the state's financial crisis, the 2011 Public Safety Realignment Act (Assembly Bill 109) was signed into law on April 4, 2011. Assembly Bill (AB) 109 transferred the responsibility for the custodial housing and supervision of specified offenders from the

California Department of Corrections and Rehabilitation to counties. Implementation of this legislation became effective October 1, 2011.

FY2019/2020 Base Funding

The AB 109 Base Funding Allocation for Tulare County for FY 2019/2020 is estimated at \$19,580,361.

On December 16, 2019, the Tulare County Community Corrections Partnership (CCP) unanimously approved a Base Funding distribution for FY 2019/2020. The CCP voted to allocate \$1,000,000 to the Health and Human Services Agency (HHSA) for Inmate Healthcare and \$676,975 for the Pre-Trial Court, \$380,410 for the District Attorney's Office, \$380,410 for the Public Defender's Office, and the remaining balance of \$17,142,566 will be distributed equally between the Sheriff's Office and the Probation Department, with each department allocated \$8,571,283. Should there be any changes to the estimated Base Funding amount, shares of the Sheriff's Office and the Probation Department will be adjusted accordingly.

FY 2018/2019 Growth Funding

FY 2018/2019 Growth Funding for Tulare County is \$1,060,021. Ten percent (\$106,002.10) of this funding will remain in the Local Innovation Fund pursuant to Government Code 30029.07. On December 16, 2019, the Community Corrections Partnership (CCP) voted to distribute the remaining balance of \$954,018.90 equally between the Sheriff's Office (\$477,009.45) and the Probation Department (\$477,009.45), which is consistent with the historical split of the Base Funding allocation.

**FISCAL IMPACT / FINANCING:**

The 2011 Public Safety Realignment Act projected Base Funding for 2019 at \$19,580,361 is included in each department's FY 2019/2020 approved budget in accordance with the CCP-approved allocation of funds to each respective department.

FY 2018/2019 Growth Funding for Tulare County is \$1,060,021. Ten-percent (\$106,002.10) is deposited into the Local Innovation Fund (Trust Fund 590-2651). The remaining balance of the Growth Funding (\$954,018.90) is deposited to the Community Corrections Growth Special Account (Trust Fund 594-2649). The ten percent (\$106,002.10) will remain in the Local Innovation Fund, while the ninety percent (\$954,018.90) will be split evenly (\$477,009.45) and will be transferred to the respective trust fund accounts maintained by the Sheriff's Office (Trust Fund 534) and the Probation Department (Trust Fund 523).

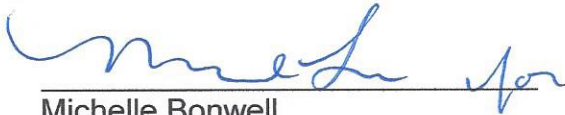
There will be no net County cost to the General Fund associated with this request.
