Per Elections Code Section 7228 and 7423, if the Elections Official finds that the number of candidates nominated for election to the Central Committees does not exceed the number of candidates to be elected the names of the candidates shall not be printed on the party's ballot. In lieu thereof, the Board of Supervisors shall declare elected the candidates who have been nominated.
