Improvements Project

REQUEST(S):

That the Board of Supervisors:

- 1. Accept the work for the construction of the Avenue 152 Safety Improvements Project, west of the City of Porterville, as complete by MAC General Engineering, Inc. of Porterville, California; and
- 2. Authorize the Chairman to sign the Notice of Completion; and
- 3. Direct the Clerk of the Board to have the Notice of Completion recorded with the County Recorder.

SUMMARY:

This Notice of Completion is for the construction of the Avenue 152 Safety Improvements Project. This project overran allowable working time; however, it was completed below the allowable budget. The work was performed by MAC General Engineering, Inc. under Tulare County Agreement No. 28785.

This project was approved by your Board on May 22, 2018 (Resolution No. 2018-0384). The lowest responsible bid was submitted by MAC General Engineering, Inc. On August 14, 2018, your Board awarded and approved a contract (Resolution No. 2018-0685) to MAC General Engineering, Inc. in the amount of \$1,575,558.78.

This project included the installation of rumple strips (center and edge line), guardrails, signs, pavement markings, flashing beacons and a traffic signal at Avenue 152 and Road 208. In addition to the improvements, left turn lanes where added along the Avenue 152 corridor at Road 120, Road 160, Road 168, Road 172, Road 200 and

Road 208.

There were three Contract Change Orders (CCO) written for the project with a net total cost of \$430.37. The first CCO was written in the amount of zero dollars to revise the placement of the guardrail systems. The second CCO was written in the amount of \$5,569.63 to credit the County as set forth in the "Payment Adjustment for Price Index Fluctuations" clause and for over run and under run items. The final CCO was written in the amount of \$6,000 to compensate the Contractor for performing additional utility pothole verification work required for the installation of the guardrail systems.

Work on this contract was completed 21 working days beyond the calculated date of completion. Since the Contractor overran the number of working days authorized for the project, liquidated damages have been assessed. The total amount of liquidated damages was established at 21 working days with a penalty of \$3,000 per day. The total amount of liquidated damages withheld is \$63,000.

In addition, the Contractor will be assessed with a penalty in the amount of \$2,409.62 as provided in Public Contract Code Section 4110. This penalty came as a result of the Contractor making an unauthorized and unwarranted sub-contractor substitution without prior approval by the Engineer. The Contractor was notified of the violation and withholding at the time the substitution was made and has made no valid objection to the assessed penalty.

This project has been completed in accordance with the plans and specifications and is now ready for acceptance by the Board.

An allowance of 5.79% of the contract bid amount, or \$91,277, was authorized for contingencies at the time of award setting the total approved contract amount at \$1,666,835.78.

The final cost to complete this project was \$1,502,785.37 which is 4.62% below the bid amount and is 9.84% below the authorized contract amount plus contingencies.


