## SUBJECT:

Approve the increase to the number of board members for Eshom Valley Cemetery District

#### REQUEST(S):

That the Board of Supervisors:

- Approve the request by the Board of Trustees of the Eshom Valley Cemetery
  District to increase the number of board members from three to five members.
- Set the terms of the new board members so that one new board member will serve a short term expiring in 2022, and the other board member will serve a full term expiring in 2024.
- Accept the resignation of current Trustee Joni Jordan (term ending 2022).
- Direct the Clerk of the Board to post the appropriate notices to fill the vacancies.

#### SUMMARY:

Eshom Valley Cemetery District (near Badger) runs a small cemetery, which has only a few burials per year. The district has no employees, so all necessary work is done by volunteers. Three local residents have indicated they would be interested in assisting the district if they were given formal status. The District currently has a board of trustees of three members, and would like to have these residents also be board members.

Health and Safety Code section 9025 provides that the board of trustees of a cemetery district may adopt a resolution requesting that the Board of Supervisors

increase the number of members of the board of trustees. Health and Safety Code section 9021 provides that when a new cemetery district is formed, the Board of Supervisors is to give the district either three or five board members. While the statutes do not address other possible sizes which a board of trustees could request, these statutes clearly authorize a board of trustees to request, and the Board of Supervisors to approve, a request to increase the number of trustees from three to five.

The attached resolution requests that the Board of Supervisors increase the number of trustees on the board of the Eshom Valley Cemetery District from three to five. To make room for all three of the interested people, current board member Joni Jordan has submitted her resignation, which will go into effect only if the Board of Supervisors approves the district's request. A copy of her resignation letter is also attached.

## LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic plan includes Quality of Life, which includes the goal of developing and sustaining a well-qualified pool of board members in the special districts. Increasing this board to five members will help the Eshom Valley residents continue to support their local cemetery.
