Update on 2020 Census Complete Count Outreach

#### REQUEST(S):

That the Board of Supervisors:

Receive an update on the 2020 Census Complete Count Outreach.

#### **SUMMARY:**

On November 9, 2018, the State of California Complete Count (CCC) distributed letters to all Counties informing of available funding for Census outreach. The California Legislature has appropriated \$90.3 million to fund activities related to the 2020 Census. The CCC, which is spearheading the state 2020 Census outreach strategy, is making \$26.5 million available to participating counties in California. Tulare County was allocated \$582,714 for Census outreach.

On January 29, 2019, the Board adopted Resolution 2019-0072, adopting the resolution to participate in the 2020 Census County-Optional Agreement and Authorized the Chairman to sign the Opt-In letter. On March 26, 2019, the Board approved the State grant agreement number CCC-18-20042.

For both the 2000 and 2010 censuses, the Tulare County Association of Governments (TCAG) was the lead agency in Tulare County for the formation of a Census Complete Count Committee and conducting outreach related to the California Complete Count. In terms of census outreach, California is considered to have one of the largest proportions of "hard to reach" populations in the nation. Tulare County is also considered to have one of the highest proportions in the state. Tulare County has approached TCAG to again take the lead in these tasks for the 2020 Census. The agreement between TCAG and the County was executed on

The Tulare County Regional Complete Count Committee is comprised of representatives from a wide range of government, education, business, healthcare, media, and community-based organizations. The Committee has met ten times, with about 50 people in attendance at each meeting. At the meetings, the committee discussed the outreach plan, partnership coordination, budgeting, and drafting of the Census Implementation Plan.

The Census Implementation Plan was submitted to the State on November 1, 2019, and approved December 6, 2019. The Implementation Plan serves to address broad census goals, objectives, and specific outreach strategies. The Plan identifies over 20 partner organizations to participate in outreach activities to promote the Census to our hard to reach population. The Plan identifies over 50 proposed locations to hold Questionnaire Assistance Centers and Kiosk (QAC/K).

At the most recent meeting held on January 14, the committee discussed a draft Census questionnaire guide developed by the Central Valley Equal Voice Network, a partner member. The guide would include all the questions the official Census questionnaire would include in English and Spanish. Our understanding is the guide will be shared with all other partner organizations for distribution at outreach events and to clients to simplify the process of completing the questionnaire form. The committee also discussed the draft of the "We support the Census / The Census supports us" poster designed to increase community awareness that the ability of local organizations to provide services is affected by Census counts. More than 30 local organizations have asked to include their logo as part of the poster.

The committee also reported information about recently completed and upcoming outreach opportunities. A description of outreach activities from November 16 through January 10 is provided in the following table.

## **Key Dates for the upcoming Census**

- March 12 20: Households will begin receiving official Census Bureau mail with detailed information on how to respond to the 2020 Census online, by phone, or by mail.
- March 30 April 1: The Census Bureau will count people who are experiencing homelessness over these three days. As part of this process, the Census Bureau counts people in shelters, at soup kitchens and mobile food vans, on the streets, and at non-sheltered, outdoor locations such as tent encampments.
- April 1: Census Day is observed nationwide. By this date, every home will receive an invitation to participate in the 2020 Census. Once the invitation arrives, you should respond for your home in one of three ways: online, by phone, or by mail. When you respond to the Census, you'll tell the Census Bureau where you live as of April 1, 2020.
- April: Census takers will begin visiting college students who live on campus, people living in senior centers, and others who live among large groups of people. Census takers also begin conducting quality check interviews to help ensure an accurate count.
- May July: Census takers will begin visiting homes that haven't responded to the 2020 Census to help make sure everyone is counted.

# **How To Complete the Census**

• By Mail: The paper Census form will be available in English and Spanish languages and can be mailed back to the U.S. Census Bureau.

- By Phone: The Census can be completed by phone in 13 languages including Telecommunication Device for the Deaf.
- Online: For the first time, the Census form will be available to complete in 13 languages.

#### FISCAL IMPACT/FINANCING:

There will be no Net County Cost to the General Fund.
