Approve Fiscal Year 2019/20 Capital Asset Purchase Modifications

REQUEST(S):

That the Board of Supervisors:

- 1. Approve an increase of \$57,500 to the Capital Asset Request Number F00092 to purchase a Fire Engine Type III to an amount not to exceed \$462,500 in Fiscal Year 2019/2020; and
- 2. Approve the modification to the Capital Asset Request Number F00087 to purchase a Fire Engine Type III instead of a Fire Engine Type I which will result in a cost decrease of \$57,500 to an amount not to exceed \$462,500 in Fiscal Year 2019/2020.

SUMMARY:

The Fire Department budgeted a total of \$925,000 to purchase two fire engines in FY 2019/20; one Type I Engine, and one Type III Engine. The Fire Department budgeted \$520,000 for the Type I Engine and \$405,000 for the Type III Engine. The Type I Engine is the larger of the two engines. It is used for structural firefighting and operates at 1,250 gallons per minute and has a 700-gallon tank, while the Type III is specifically designed to fight wildfires by transporting firefighters to the scene and providing them with access to the fire along with water and other equipment.

At the time of order, the Fire Department was informed that pricing for both Type I and III engines had significantly increased in cost. Generally, the cost of fire engines increases approximately 3% annually. In light of this, the Fire Department would like to modify the original spending plan to purchase two Type III Fire Engines

in an amount not to exceed \$462,500 each maintaining a total purchase of \$925,000 for both capital assets.

Although purchasing a Type I and a Type III engine would have been ideal, the price increase was just too high and not within the Fire Department's approved budget for Fiscal Year 2019/20. Moving forward, the Fire Department will continue to work with County Administration to establish a vehicle replacement schedule so that the department may continue the process of rotating out the aging apparatus currently in our fleet.

FISCAL IMPACT/FINANCING:

The Fire Department budgeted a total of \$925,000 to purchase two fire engines in FY 2019/20; one Type I Engine (\$520,000), and one Type III Engine (\$405,000). The Fire Department is requesting to modify the purchase of the Type I Fire Engine to a Type III Engine in an amount of \$462,500, and increase the existing approved Type III Engine from \$405,000 to \$462,500. Approval of the requests will maintain a combined total of \$925,000 for these two capital assets in FY 2019/20. There is no additional net County cost costs to the General Fund.
