Changes to the Fee schedule of the Tulare County Treasurer-Tax

Collector.

REQUEST(S):

That the Board of Supervisors:

1) Approve the attached proposed fee schedule, to be effective July 1, 2020.

SUMMARY:

The Treasurer-Tax Collector is updating two fees. Each fee represents a separate payment plan that is available to pay off property taxes owed.

The first is the Redemption Payment Plan. This plan is available to any person who has prior year defaulted taxes on a secured property. This payment plan allows a person to pay off the delinquent balance in installments over a five year period. Pursuant to Revenue and Taxation code section 4217 (b), any person wishing to pay delinquent taxes installments is subject to a fee.

The second is the Special Payment plan. This plan is available to any person who received one or more tax bills in addition to their regular annual bill. The additional bill(s) are known as escape assessments and result from a correction in value to the prior year tax roll. These corrections result in an increase in taxes. The special payment plan allows a person to pay the escape assessments in installments without incurring any penalties. Pursuant to Revenue and Taxation code section 4837.5 (I), the tax collector may establish a fee for the actual cost of processing these plans.

The Treasurer-Tax Collector reviewed all of its fees, and specifically with respect to these two fees, this review revealed a more efficient process than when the fees were first adopted, and so a reduction for both fees is requested. The Treasurer-Tax Collector is requesting the fee for the Redemption Payment Plan be adjusted from \$140 to \$50 per parcel (which is a 65% drop) and for the fee for the Special Payment Plan be reduced from \$255 per assessment to \$100 per parcel (which is roughly a 60% reduction).

FISCAL IMPACT/FINANCING:

The approval of this action will likely reduce revenue to the office about \$16,000, since the Redemption Pay Plan fee is being reduced from \$140 to \$50, and the Tax Collector received payment last fiscal year on roughly 180 plans. The Special Payment Plans are much less common, and so little to no fiscal impact is expected due to their fee reduction.
