Enact Special Event Permit fee. To establish cost recovery for Special Event permits.

- No new requests for fee increases (Only prior approved escalations)
- Only one fee is impacted
- Total individual fee increase is \$90.00

Setback Variance — Setbacks are building restrictions imposed on property owners. Property owners can petition the County for special permission to depart from the regulations, known as a "Variance".

Setback Variance Fee Increase- \$90

Rationale: Approaching Full Cost Recovery while still being Business Friendly and Promoting Economic Development through Reasonably Phased Fee Increases

Compared 3 years history of fee revenue and expenses to determine the percentage of cost recovery for each fee.

Setback Variance

\$2,796

Five Year Increase began: July 1, 2016


Annual Increase: \$90 per year

This year's pro rata increase brings the fees from \$1,260 to \$1,350 (Final Incr.)

RMA Road Division Fees Overview

- Several "Special" events are held in Tulare County every year such as parades, running or cycling events.
- RMA handles review and approval which can require some or all of the following:
 - Review and approve street closure/detour plans.
 - Review and approve traffic control plans.
 - Review and approve insurance documents.
 - Prepare an agenda item for Board approval for inaugural events.
- Currently no "Special" event fee, but staff costs average over \$1,000 per event.


