SUBJECT: Approve an amendment to Agreement No. 28273 with AllPaid, Inc.

REQUEST(S):

That the Board of Supervisors:

1. Approve an amendment to Agreement No. 28273 with AllPaid, Inc. (d/b/a "GovPayNet") (f/k/a Government Payment Service, Inc.) to extend the term of Agreement through June 30, 2021 for the purpose of accepting credit and/or debit card payments; and
2. Authorize the Chairman to sign four (4) copies of the Agreement.

SUMMARY:

The Tulare County Probation Department collects various fees for services rendered, as authorized by law. These fees contribute to General Fund revenues, and are collected through various methods including cash payments, tax intercepts by the Franchise Tax Board, and credit/debit cards paid online or via phone to AllPaid, Inc., on behalf of the County. The Sheriff's Department, Health and Human Services Agency, Resource Management Agency, and the Assessor/Clerk-Recorder also utilize AllPaid, Inc. to collect fees and taxes paid with credit/debit cards.

The Probation Department has had an established relationship with AllPaid, Inc. since April 24, 2012 as they have the equipment that provides the paying party the option to pay with a credit/debit card on a walk-in basis, online, and/or via phone payment.

2017. There were no substantive deviations from the County standard contract boilerplate identified in the original agenda item. The County and AllPaid, Inc. have previously entered into two (2) amendments. Amendment #28273-A was entered for the period of period of July 1, 2018 through June 30, 2019 and #28273-B was entered for the period of July 1, 2019 through June 30, 2020. The parties now wish to amend the Agreement to extend the term through fiscal year 2020-21.

The proposed amendment to Agreement No. 28273 does not include any substantive deviations from the standard County boilerplate. The only change to the original agreement, as amended to date, is a change in the time period of the agreement.

FISCAL IMPACT/FINANCING:

There are no net County costs. The County will not pay for any costs of the implementation of this collection service. All Paid, Inc. will provide the necessary equipment and training, and will charge the paying party a convenience fee to defray operating costs.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic business plan includes the Organizational Performance to continuously improve organizational effectiveness and fiscal stability. The approval of this Agreement helps fulfill this initiative by providing more options to the clients in settling their accounts, thus enabling the Department to enhance its collection performance and increase its revenues.
