SUBJECT: Approve an Amendment to Agreement No. 27885 with the County of Inyo

REQUEST(S):

That the Board of Supervisors:

1. Approve an amendment to Agreement No. 27885 with the County of Inyo to extend the term of the Agreement through June 30, 2021 to provide facilities and services for the detention and/or commitment of juvenile offenders at a rate of \$135 per bed per day; and
2. Authorize the Chairman to sign four (4) copies of the Agreement.

SUMMARY:

The County of Inyo closed its full-time juvenile detention facility and converted it into a special purpose weekend commit facility, thus creating a need for detention bed options for those occasions when it has a juvenile in need of full-time detention.

In order to address this need, the Inyo County Probation Department entered into Agreement No. 27885 with the County of Tulare, through the Tulare County Probation Department, to provide housing accommodations for their minors. This agreement has been utilized once during the four (4) years that it has been in place. Beginning in February 8, 2017, one Inyo County juvenile offender was booked and housed in the Tulare County Juvenile Detention Facility for a period of 23 days. The current contract expires June 30, 2020.

It is now the desire of the County of Inyo to extend the term of the Agreement one additional year for facilities and services for the purpose of detention and/or

commitment of its juvenile offenders. In exchange, the County of Tulare will continue to charge the County of Inyo for the cost of detaining and providing services for its juvenile offenders.

Agreement No. 27885 was approved by the Board of Supervisors on November 1, 2016 for the remainder of fiscal year 2016-17. The substantive deviation from the standard County contract boilerplate identified in the agenda item for the original Agreement was: mutual indemnification. The County of Tulare and the County of Inyo have previously entered into three (3) amendments. Amendment No. 27885-A was entered for the period of July 1, 2017 through June 30, 2018. Amendment No. 27885-B was entered for the period of July 1, 2018 through June 30, 2019. Amendment No. 27885-C was entered for the period of July 1, 2019 through June 30, 2020.

The proposed amendment to Agreement No. 27885 does not include any substantive deviations from the standard County boilerplate. The only change to the original agreement, as amended to date, is a change in the time period of the agreement.

FISCAL IMPACT/FINANCING:

The County of Inyo will reimburse the County of Tulare the amount of \$135 per bed occupied by each juvenile offender, per day, each and every day (or partial day) for the entire term of the agreement for such services. In the past three fiscal years that this agreement has been in place, the County has housed a total of one (1) juvenile offender from the County of Inyo in the Juvenile Detention Facility. There is no net County cost to the General Fund.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic business plan includes a Safety and Security Initiative. This initiative provides for the safety and security of the public through the provision of facilities and resources for training and rehabilitating criminal offenders.
