- 1.2 The SPONSOR will advertise, award, and administer the Project(s) in accordance with SPONSOR standards.
- 1.3 Contract award information shall be submitted by the SPONSOR to the AUTHORITY within 60 days after the Project contract award.
- 1.4 Failure to submit contract award information in accordance with section 1.3 will cause a delay (without interest or penalties) in AUTHORITY processing invoices for the construction phase of the Project.
- 1.5 If no costs have been invoiced for a six month period, SPONSOR agrees to submit for each phase a written explanation of the absence of Project(s) activity along with target billing date and target billing amount.

Project Scope

The scope of work for this Project includes the preliminary engineering, right-of-way and construction phase of the Bridge Preventive Maintenance Program Group 5 Project. Through this Program Supplement, Tulare County anticipates soliciting all necessary contracts (including, but not limited to, environmental, hydraulic, and geotechnical consultants) to perform all necessary studies and Project design.

Project Schedule

The preliminary engineering phase of the Project will take approximately 4 years to complete, depending on Project constraints and requirements. Construction of this Project is tentatively scheduled to start in the fall of 2024 and will take approximately 18-24 months to complete.
