SUBJECT: 2020/2021 County Transportation Improvement Program (CTIP)

REQUEST(S):

That the Board of Supervisors:

- 1. Approve the 2020/2021 County Transportation Improvement Program; and
- 2. Direct staff to take appropriate action to implement the 2020/2021 County Transportation Improvement Program.

SUMMARY:

The 2020/2021 County Transportation Improvement Program (20/21 CTIP) identifies the Resource Management Agency's (RMA) improvement and maintenance strategy for the County's transportation infrastructure for Fiscal Year 2020/2021 (FY 20/21).

The proposed list of projects in the 20/21 CTIP are shown on the attached FY 20/21 CTIP Table (Attachment A). In this program, there are 56 distinct projects with a total estimated project cost of \$55,928,675. Revenue sources for these projects include, but are not limited to local Measure R funds, State and Federal funding sources, and State Road Maintenance and Rehabilitation Account (RMRA) funds. Additional details on County transportation funding sources, project identification and selection, and program implementation are provided below. Note that general road maintenance activities such as pothole repairs, shoulder clearing, sign maintenance, snow removal etc. are not included in the CTIP.

Funding

Tulare County receives funding for transportation projects from a variety of sources. These sources are divided into three categories: Local, State, and Federal. Local

sources consist primarily of Measure R (1/2 cent sales tax specifically for transportation) and some Maintenance assessment district revenues. State sources include Local Transportation Funds (from sales tax), Senate Bill 1 (SB 1) and Highway User Tax Account (legacy gas tax). Federal sources include a variety of competitive grant funds as well as allocations from transportation spending legislation which can vary from year to year. A Road fund balance does exist for transportation projects, emergencies and other necessary reserves. No property taxes or County general funds are applied to road maintenance and construction within Tulare County.

Local Funds

On November 6, 2006, Measure R (MR) was approved allowing the Tulare County Association of Governments (TCAG) to impose a ½ cent retail transaction and use tax for 30 years (between April 1, 2007 and March 31, 2037). A Tulare County ½-cent Transportation Sales Tax Expenditure Plan was prepared by TCAG and approved by nine member agencies (Dinuba, Exeter, Farmersville, Lindsay, Porterville, Tulare, Visalia, Woodlake, and the County of Tulare) that outlines where the MR funds will be spent and what categories of projects will be funded. The funding categories and the MR funds guaranteed for each category is as follows:

- Regional Transportation Program (50% MR funds)
- Local Transportation Program (35% MR funds)
- Transit/Bikes/Environmental Mitigation (Air Quality) Program (14% MR funds)
- Administration and Planning Program (1% MR funds)

Through the Local Transportation Program category of MR (hereinafter referred to as "MR Local"), the County receives an annual allocation of approximately \$5.6 million to develop a priority list of projects based on community needs. MR Local funds allow for road improvements projects such as pothole repairs, road rehabilitation, adding travel lanes, and other transportation related projects.

However, on October 15, 2019, your Board approved a \$10 million advance in MR Local funds for the design and construction of six (6) high priority Farm 2 Market Routes, collectively identified as the Farm 2 Market Program 2.0. As a result of the \$10 million advance, there will be a reduction to the County's MR Local funds allocation of approximately \$800,000 each fiscal year starting Fiscal Year 2020/2021 for the remaining life of MR (ending Fiscal Year 2036/2037). The Farm 2 Market Program 2.0 has an estimated total project cost of \$11 million. An estimated \$1 million County Road funds will cover the additional funds needed to complete the projects identified in the Farm 2 Market Program 2.0.

Through the Regional Transportation Program of MR (hereinafter referred to as "MR Regional"), MR Regional funds can be used for all phases of project development and implementation for regional transportation projects identified in TCAG's adopted Regional Transportation Plan (RTP) that is updated every two years. These projects are approved by all member agencies in Tulare County and were selected through a process that evaluated safety, performance measures and cost effectiveness in order to improve the movement of goods, services, and people throughout Tulare County.

Projects funded with MR Regional funds requires an agreement between the County and TCAG in the form of a Program Supplement.

RMA has budgeted approximately \$21 million (which includes the \$10 million advance to fund the Farm 2 Market Program 2.0) in local Road funds and Road fund balance reserves to fund the Design, Right of Way, and Construction Phases of various projects. These funds will also be used to leverage federal/state funded "grant" type projects, various maintenance projects (i.e. blade patching), and countywide projects such as the Rapid Response Program (i.e. repairs that are identified for immediate attention throughout the fiscal year). A summary of the countywide projects (eight in total) is detailed below.

Of the \$21 million of local Road funds budgeted for projects, staff is proposing to allocate approximately \$1 million (a combination of MR Local and MR Regional funds) to leverage approximately \$6.6 million of federal/state funded "grant" type projects. Utilizing local Road funds will allow the County to cover the required match for these types of projects. Further, strategically appropriating local Road funds, to leverage federal/state funded "grant" type projects, is a cost-effective approach to providing additional benefits to communities that would not have otherwise been possible. For example, drainage related improvements that directly/indirectly benefit motorized users for a sidewalk project funded through the Active Transportation Program (e.g. asphalt concrete paveouts and storm drainage facilities to provide adequate drainage) is typically considered non-eligible work: ineligible for reimbursement.

Additionally, staff is proposing to allocate \$700,000 for engineering, design, inspection, and construction management costs associated with projects identified on the CTIP.

State Funds

In April of 2017, California passed Senate Bill (SB) 1 – the Road Repair and Accountability Act in order to address the significant multi-modal transportation shortfalls statewide. This bill established a new funding source for road repairs and maintenance through revenue from gas taxes and vehicle registration fees and other transportation related fees. A significant portion of these funds are distributed to local agencies in the form of RMRA funds (i.e. SB 1 funding).

To receive these funds, RMRA guidelines for the expenditure of RMRA funds require a project identification through a formal Board Resolution. Staff is concurrently requesting the Board (in a separate Agenda Item) to identify and approve the project description, locations, schedule, and estimated useful life per RMRA guidelines for the following three projects in the County's Fiscal Year 2020/2021 Budget: (1) 2021 Road Repair and Accountability Act (RRAA) Project 1, (2) 2021 Road Repair and Accountability Act (RRAA) Project 2, and (3) 2021 Road Repair and Accountability Act (RRAA) Project 3.

These three RRAA projects account for 16 locations and over 26 miles of roads to be repaired. This is the fourth year in which Tulare County will be receiving SB 1 funding

(approximately \$12.7 million) enabling the County to continue to provide essential road maintenance and rehabilitation projects for the traveling public that would not have otherwise been possible without SB 1 funding. The proposed 2021 RRAA projects to be constructed using SB 1 funding are included in this year's CTIP. Construction for these projects are anticipated to begin spring of 2021 and proposed to be completed by fall of 2021.

In addition to SB 1 funds, Tulare County is projected to receive approximately \$14.5 million in other gas tax funds through the State's Highway User Tax Account (HUTA) program. These funds, like SB 1, are primarily from the proceeds of gas taxes and vehicle registration fees.

However, due to the unforeseen COVID-19 global pandemic, it is unknown at this time the magnitude of impacts to fuel tax (SB 1 and HUTA) revenues due to the apparently significant decrease in driving and fuel consumption as Californians "shelter in place" consistent with Governor Newsom's Executive Order N-33-20.

Should actual fuel tax revenues in the upcoming months differ substantially from the projected amount the County is expected to receive, RMA staff will reevaluate the proposed 2021 RRAA projects to determine the optimal project delivery strategy. Possible strategies may include reduction in project scope, postpone select projects to future fiscal years, or utilize Road funds reserves to complete the projects.

Federal Funds

Federal funding sources include funds from the Highway Bridge Program (HBP), the Highway Safety Improvement Program (HSIP), the Active Transportation Program (ATP), the Surface Transportation Block Grant Program (STBGP), and the Railway-Highway Crossings (Section 130) Program. These funds are typically awarded on a grant basis based on competitive applications for funding (excluding STBGP and Section 130), are paid on a reimbursement basis, and are generally focused on capital improvements.

Project Identification – Community Involvement

RMA continues to perform an aggressive community plan updating process as part of the implementation of the General Plan approved by the Board of Supervisors. The new community plan updates include numerous community outreach events wherein transportation needs are frequently prioritized and discussed with residents. It is through this outreach and needs identification process with the communities and residents of Tulare County that many of the concepts for capital improvements originate.

In recent years, RMA staff completed an exhaustive survey of school transportation facilities and prepared the Tulare County-wide Safe Routes to School (SRTS) Plan – Phases 1 and 2. Moreover, the Complete Streets Policies, in addition to the community plan update process as well as the SRTS plans, identify locations where the improvements to the transportation network can have substantial safety and efficiency impacts for the communities and schools.

These priority projects, in addition to County's bridge replacement/rehabilitation projects and road maintenance projects, make up the 20/21 CTIP.

Rocky Hill Drive and Firebaugh Avenue Improvements Project

The County, TCAG, and the City of Exeter have recognized the commercial and industrial impacts and the need for road improvements on Rocky Hill Drive and Firebaugh Avenue. The purpose of the Rocky Hill Drive and Firebaugh Avenue Improvements Project is to improve the Rocky Hill Drive and Firebaugh Avenue corridors between State Route 65 and Road 204 to improve commercial vehicle circulation and enhance safety for pedestrians and cyclists in the area.

Staff is working closely with TCAG staff to secure \$400,000 of MR Regional funds to fund the Preliminary Engineering (PE) phase of the Rocky Hill Drive and Firebaugh Avenue Improvements Projects. Staff will continue to work with TCAG to acquire MR Regional funds for the Right-of-Way and Construction/Construction Engineering phase at a later date.

Since this project is a joint effort between the County and the City of Exeter, a Cooperative Agreement between the County and the City of Exeter will be required for this project.

Avenue 280 Widening Project – Segment 2 and Segment 3

The Avenue 280 Widening Project consists of the widening of the Avenue 280, a principal east-west major arterial that links State Route 99 and the cities of Visalia, Farmersville, and Exeter, as well as unincorporated areas of Tulare County. The purpose of widening the Avenue 280 corridor is to improve traffic operations, reduce congestion, and improve the regional transportation and circulation system in the adjacent portions of Tulare County and the cities of Visalia, Farmersville and Exeter.

Segment 1 of the Avenue 280 Widening Project consisted of widening Avenue 280 to a four-lane roadway with center median and turn lanes between State Route 99 and Road 100 (Akers Street). This project also included the installation of Class 2 bike lanes, pedestrian facilities, street lighting, traffic signal at Avenue 280 and Road 92 (Shirk Street), raised decorative concrete median treatments, and a new double box culvert crossing of Road 92. Your Board accepted the work for the construction of the Avenue 280 Widening Project – Segment 1 as complete by Cal Valley Construction, Inc. (Notice of Completion signed and filed on January 7, 2020).

Segment 2 of the Avenue 280 Widening Project will widen an approximately 2.5-mile stretch of the existing two-lane roadway to a four-lane divided roadway with a center median and/or turn lanes with intersection improvements between Lovers Lane (City of Visalia limits) and Virginia Avenue (City of Farmersville limits). The total cost of Segment 2 of the Avenue 280 Widening Project is currently estimated to be \$24,000,000.

Segment 3 of the Avenue 280 Widening Project will widen an approximately 1.8-mile stretch of the existing two-lane roadway to a four-lane divided roadway with a center

median and/or turn lanes with intersection improvements between Brundage Avenue (City of Farmersville limits) and Road 184 (Elberta Road). The total cost of Segment 3 of the Avenue 280 Widening Project is currently estimated to be \$17,700,000.

According to the 2018 Measure R Strategic Work Plan (a five-year master plan for the delivery of Measure R projects), MR Regional funds for the PE phase of these projects are programmed in Fiscal Year 2022/2023. Because the Avenue 280 corridor is a high priority road segment for the region, staff is working closely with TCAG staff to accelerate MR Regional funds to FY 20/21, a combined total of \$2.7 million of MR Regional funds (\$1.5 million for Segment 2 and \$1.2 million for Segment 3), to fund the PE phases of these projects.

Staff will continue to work with TCAG to acquire MR Regional funds for the Right-of-Way and Construction/Construction Engineering phases at a later date. At this time, the timing of the funding availability for Phase 3 of the project is somewhat uncertain due to the potential impacts from the COVID-19 economics.

Teapot Dome Reconstruction Project

On January 7, 2020, the BOS approved a Memorandum of Understanding and Intergovernmental Agreement (MOU) with the Tule River Indian Tribe and Tule River Tribe Authority for the relocation and expansion of the Eagle Mountain Casino to Porterville. The new Eagle Mountain Casino will be located on a 40-acre site on the east side of West Avenue, approximately 720 feet south of Scranton Avenue and the Porterville Sports Complex, all within the Porterville City limits, just west of the Porterville Airport.

In an effort to mitigate traffic impacts to County roads in the vicinity of the new Eagle Mountain Casino, one of the mitigation measures the MOU details require that the County design and construct certain improvements to Teapot Dome Avenue between West Street and Newcomb Street. As part of the MOU, the Tule River Indian Tribe and the Tule River Tribe Authority will contribute their pro-rata fair share of the project improvement costs.

The total cost of the Teapot Dome Reconstruction Project is currently estimated at \$2.8 million. Staff is proposing to budget \$200,000 in local Road funds to fund the PE phase of the Teapot Dome Reconstruction Project. Staff will evaluate funding alternatives to fund the construction phase. It is likely that Road Fund reserves will be used for this purpose.

Bridge Improvement Program

The County is responsible for the maintenance of 358 bridges (measuring 20-ft and longer) on County roads. The average age of the County's bridges is approximately 65, and many structures are nearing the end of their service life. For this reason, the County implemented a Bridge Improvement Program with the goal of addressing the County's aging bridge inventory. This program is intended to repair or replace existing bridges considered "Structurally Deficient" and implement preventive maintenance needed to extend the service life of the County's bridges.

The Bridge Improvement Program is predominately funded by the Federal Highway Administration's (FHWA) Highway Bridge Program (HBP). The HBP is a nationwide program that provides funding for our nation's bridges that are in need of rehabilitation, repair or replacement. Supplemental funding for this program (local match required for on-system bridge projects) is provided by MR transportation funding (more specifically, MR Regional funds).

The County currently has 14 programmed bridge projects (i.e. projects that have received funding allocation). Staff anticipates receiving federal authorization to proceed (E-76) with the construction phase on four of the programmed bridge projects in FY 20/21 (see below). No local match will be required for these four bridge projects.

- Avenue 424 Bridge Replacement over Traver Canal
- Avenue 392 Bridge Replacement over Sand Creek
- Avenue 364 Bridge Replacement over Cottonwood Creek
- Road 204 Bridge Replacement over Wutchumna Ditch

RMA previously received HBP funding for various phases (Design, Right-of-Way or Construction) for all currently programmed projects (with the exception of the Avenue 152 Bridge Replacement over Tule River Project). Of the 14 programmed projects, the following bridge projects are introduced to this year's CTIP:

- D112 Bridge Replacement over Bates Slough
- Road 112 Bridge Replacement over North Branch Tule
- Avenue 108 Bridge Replacement over Lakeland Canal
- Avenue 152 Bridge Replacement over Tule River
- Avenue 174 Bridge Replacement over Friant-Kern Canal

RMA is also developing a Bridge Preventive Maintenance Program (BPMP) for bridges under 20-ft in length (programmed in 19/20 CTIP). Bridges and culverts with a total length less than 20-ft do not qualify for federal funding, therefore, Tulare County is responsible for 100% of the cost to manage and maintain these structures (including the cost to rehabilitate or replace the structures). Through prior Board action, \$250,000 in MR Regional funds needed to develop the County's Under 20-ft BPMP was approved. This includes a full inventory of bridges under 20-ft, an assessment of the maintenance needs, and a prioritization of these projects.

Through the data collection process for the Under 20-ft BPMP, two bridges were identified to be structurally deficient or functionally obsolescence: (1) the Avenue 430 Bridge Replacement over Buttonwillow Ditch and (2) the West Oakwood Drive Bridge Replacement over Capinero Creek. Design will be completed by Public Works staff with technical consultant support as needed. Staff will coordinate with TCAG to secure MR Regional funds to fund the Design, Right-of-Way, and Construction phases of these two projects. Staff anticipates that approximately \$500,000 is needed for the Engineering Design and Right of Way phases of these two projects.

The County also received federal BPMP funds for bridges (over 20-feet) that are eligible under the HBP funding guidelines for repairs. Additional details provided below.

Countywide Projects

Eight projects are listed in the 20/21 CTIP that cover multiple locations throughout the County include the following programs:

- Chip Seal Program
- Intersection Improvement Program
- Rapid Response Program
- ADA Improvement Program
- Slurry Seal Program (new)
- Local Road Safety Plan (new)
- Bridge Preventative Maintenance Program Group 1 (new)
- Bridge Preventative Maintenance Program Group 5 (new)

Introduced in previous CTIPs are the county's annual Chip Seal Program, the Intersection Improvement Program, the Rapid Response Program, and the ADA Improvement Program. With the Chip Seal Program, staff proposes to perform chip seal road maintenance to over 70 miles of County rural roads for a budgeted cost of \$1.5 million (MR Local funds). This program has continually proven to be the most cost-effective method to extend the service life of many County roads. With the Intersection Improvement Program, staff proposes to budget \$600,000 in MR Local funds to repair high-priority intersections that require additional surface maintenance due to increased loading from vehicular braking and acceleration. With the Rapid Response Program, staff proposes to budget \$1 million in MR Local funds to allow for prioritization of projects that arise throughout the year that are not currently identified. This work will typically be performed by County forces that can be quickly mobilized for a fast response to the need.

In August 2013, staff developed the American Disability Act (ADA) Self-Evaluation & Transition Plan for Pedestrian Right of Way (i.e. ADA Transition Plan) to fulfill the requirements set forth in Title II of the ADA. The ADA Transition Plan (which excludes public facilities and park sites) provides an inventory of existing curb ramps and sidewalk that are not ADA compliant. Staff proposes to budget \$750,000 in MR Local funds to the ADA Improvement Program.

Newly introduced in this year's CTIP is the Slurry Seal Program. With this program, staff proposes to perform slurry seal road maintenance to approximately 4 miles of County roads within unincorporated communities (more specifically, roads that have curb and gutter) for a budgeted cost of \$350,000 (MR Local funds). The purpose of slurry seal road maintenance is to preserve and protect the underlying pavement structure and provide a new driving surface.

Also new to this year's CTIP is the Local Road Safety Plan (LRSP), a safety plan that will provide a comprehensive framework to identify key safety needs and guide safety

investment decisions on County roads. Tulare County was awarded State funds (the maximum amount allowed to be requested) to prepare the LRSP in the amount of \$72,000 requiring a local match of \$8,000 to be covered by County Road Funds. Since cost to prepare a comprehensive LRSP may exceed \$80,000, staff proposes to budget an additional \$70,000 of County Road funds for the preparation of the safety plan. It is staff's intent to complete the LRSP by winter of 2021 to be eligible to apply for the Highway Safety Improvements Program (HSIP) Cycle 11 Calls-for Projects (anticipated April 2022).

Lastly, introduced to this year's CTIP are the following Bridge Preventative Maintenance Program (BPMP) projects: the BPMP Group 1 Project (methacrylate overlays on 12 bridges) and the BPMP Group 5 Project (slope and scour protection repairs on 24 bridges). The County developed a BPMP (completed in 2013) through the federal Highway Bridge Program (HBP) to assess the full inventory of County bridges over 20-ft in length (those that qualify for federal funding). The purpose of the BPMP is to extend the service life of bridges considered to be in generally good condition, by implementing preventive maintenance measures, such as protective deck treatments, scour countermeasures, joint seal replacements, etc., before major, and costly, rehabilitation or repair is required. Federal funds received for the Engineering Design phase for these two projects (a combined total of \$1,006,497) require an 11.47% local match to be covered by MR Regional funds (a combined total of \$130,403).

Summary

As proposed, the 20/21 CTIP includes a broad range of transportation projects that will be designed and or constructed starting in summer of 2020. These projects range from rural road rehabilitation projects on priority Farm 2 Market routes, to vehicle and pedestrian safety projects within the communities. These projects have been identified and developed through a comprehensive examination that includes feedback from residents during numerous community outreach events, quantitative analysis from the County's Pavement Management System, and the review of planning documents that identify needs and guide growth throughout the County.

If approved, the projects identified in the 20/21 CTIP will begin to be implemented starting in Fiscal Year 20/21. Staff will return to your Board for environmental clearance and authorization of specific projects in the program on a case by case basis as required.

FISCAL IMPACT/FINANCING:

No Net County Cost to the General Fund.

Funding for the 20/21 CTIP includes revenue sources from local Road funds (i.e. MR Local Programs and MR Regional funds), State and Federal funding sources (e.g. LRSP, HBP, HSIP, ATP, STBGP, and Section 130), the State RMRA and HUTA funds and Road fund balance.

In the proposed 20/21 CTIP, there are 56 distinct projects with a total estimated project cost of \$55,978,675.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

Safety and Security – Efficient and responsive maintenance of the county road network will enhance the safety and security of the public by improving the transportation infrastructure for the general population throughout the region.

Economic Well Being - To promote economic development opportunities, effective growth management and a quality standard of living. The projects identified in the proposed CTIP helps encourage growth consistent with the County General Plan, and improves the roadway network for efficient transportation of goods and services throughout the County.


