SUBJECT: Measure R Program Supplement Agreement with TCAG for the D112 Bates Slough Bridge Project

REQUEST(S):

That the Board of Supervisors:

- 1. Rescind Board Agreement No. 27813 (Resolution No. 2016-0731); and
- Approve the Measure R Program Supplement to Cooperative Agreement with the Tulare County Association of Governments for the Preliminary Engineering Phase, Right-of-Way Phase, and Construction Phase for the D112 Bates Slough Bridge Project, southwest of the City of Tulare, in an amount not to exceed \$185,814; and
- 3. Authorize the Chair of the Board Supervisors to sign the Measure R Program Supplement on behalf of the County of Tulare.

SUMMARY:

On May 22, 2007, Tulare County entered into an agreement (Tulare County Agreement No. 23149) with the Tulare County Association of Governments (TCAG) to utilize revenue collected under Measure R for local and regional transportation projects. The application of these funds to a particular project requires an agreement between the County and TCAG in the form of a Program Supplement.

The County is the lead agency for the D112 over Bates Slough Bridge Project (Project) that will replace the existing functionally obsolete bridge. On December 11, 2015, Tulare County received federal authorization to proceed with the Preliminary Engineering (PE) phase of the Project. On August 30, 2016, your Board approved

Agreement No. 27813 with TCAG (Resolution No. 2016-0731). Agreement No. 27813 established a not to exceed contract amount of \$44,619 for use as the local match for the Preliminary Engineering phase of the Project.

Due to scope changes and increases in the estimated cost to construct the Project, staff has submitted a request for additional Federal Highway Bridge Program (HBP) funds; therefore, additional local match funds will also be required. Per the recommendation of TCAG, and with your approval, staff proposes to rescind Agreement No. 27813 and establish a new Program Supplement with TCAG to cover the local match component (11.47%) required for all phases of the Project (Preliminary Engineering, Right-of-Way, and Construction).

The Project is nearing the completion of the 65% design phase and final design is anticipated to be complete by summer 2021. Construction is anticipated to start in the fall/winter of 2021 and will take approximately 6-9 months to complete.

FISCAL IMPACT/FINANCING:

County Road Funds will be used to fund all phases of this Project, but will be fully reimbursed through a combination of Federal Highway Bridge Program (88.53%) and local Measure R (11.47%) funds.


