<u>SUBJECT</u>: Fiscal Year 2020/2021 Operating Budget for the Seville Water Company

REQUEST(S):

That the Board of Supervisors:

- 1. Approve the fiscal year 2020/2021 operating budget for the Seville Water Company (4/5ths vote required): and
- 2. Approve the necessary budget adjustments per the attached AUD 308 (4/5ths vote required).

SUMMARY:

The County of Tulare has operated the Seville Water Company, a domestic water system for the Community of Seville, under court appointed receivership since 2009. As such, on an annual basis the County Board of Supervisors, as required, has approved an annual budget to allow continued operation of the system. In 2020 the County completed Phase I of a multi-year grant funded project to build a new water system for the communities of Seville and Yettem, to be transferred to the Yettem-Seville Community Services District (YSCSD), an independent special district. The transfer of the new system to YSCSD will not take place until the beginning of next Fiscal Year (FY), therefore it is necessary for the County to submit a final annual budget to cover the costs of operations that will continue to be the receiverships responsibility in FY 2021 until the transfer occurs. Due to the uncertainty of when the transfer will take place in FY 2021, staff is recommending adopting a budget with the same revenues and expenses as FY 2020 at a Net County Cost of \$47,463.

Chronology

The Seville Water Company provides water to approximately 74 residential connections and the Stone Corral School.

On April 28, 2009, the Board of Supervisors approved the County of Tulare becoming the temporary receiver of the Seville Water Company located in the community of Seville.

On June 11, 2009, the Tulare County Superior Court of California (Court) approved Tulare County as the temporary receiver of the Seville Water Company.

Through multiple actions, the Court has approved extensions of the temporary receivership most recently through June 30, 2021.

Voters approved in November of 2018 the formation of the YSCSD. The County intends to transfer the water system, including the completed Phase I project, to the CSD in FY 2020/21, after certain conditions have been met. Prior to transfer, the following conditions must be met:

- The County must approve an (Memorandum of Understanding (MOU) outlining the terms of the transfer
- The Water Board and Local Agency Formation Commission LAFCO must approve the MOU
- The County must file a Notice of Completion for the construction of Phase 1 of the Yettem-Seville Water System Improvement Project (the Project)
- The County must repay any balance owed on outstanding Certificates of Participation with the Yettem Water Zone of Benefit Z91 in County Service Area #1
- YSCSD must have or be able to acquire all permits and licenses necessary to operate the water systems

Staff expects to request your Board to approve the Notice of Completion at the July 7, 2020 meeting. At that time, all other conditions are expected to be met with the possible exception of approval of the MOU by Water Board.

The construction of Phase I of the Project reached substantial completion in 2020. The construction of Phase 1, including a replacement water distribution system in Seville and a fire storage tank, is funded with Prop 1b State Funds. Phase II of the Project consists of the Yettem to Seville intertie, a new well and water meters in Yettem.

In the interim, the County is responsible for the maintenance and operations of the Seville Water Company system.

Rationale for Proposed Budget Action

The Seville Water Company is not part of the County Service Area; and as such, the Water Company's budget needs to be adopted outside the normal County budget approval and adoption process.

Therefore, the attached AUD 308 identifies the proposed appropriations for

revenues and expenditures for the operation of the Seville Water Company for fiscal year 2020/2021 to be effective July 1, 2020. With such spending authority, the Water Company may continue to operate without budget constraints.

FISCAL IMPACT/FINANCING:

The FY 2021 operating budget for the Seville Water Company includes a Net County Cost of \$47,463. We anticipate the actual FY 2021 Net County Cost to be much less, but it is dependent upon the length of time it takes to transfer the system to YCSCD. Additionally, costs associated with the closeout of the Phase I grant and Phase II grant application preparation have been budgeted. The grant related costs are fully reimbursable under the current Phase I grant (expiring in August 2020) and retroactively under the Phase II grant (anticipated to be approved in spring of 2021).

The objective of the budget is to operate the Seville Water Company, under receivership, at a minimal Net County Cost to the General Fund. In the past due to the poor condition of the system abnormal maintenance costs have been necessary. The proposed budget includes a request for adequate budget to respond to emergency events from leaks and electrical issues.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic plan includes a Quality of Life initiative to promote public health and improve environmental quality. Infrastructure improvements assist the Seville and Yettem water systems in meeting safe drinking water standards for its domestic water supply and decreases the contamination risk to human health, as well as the environment.

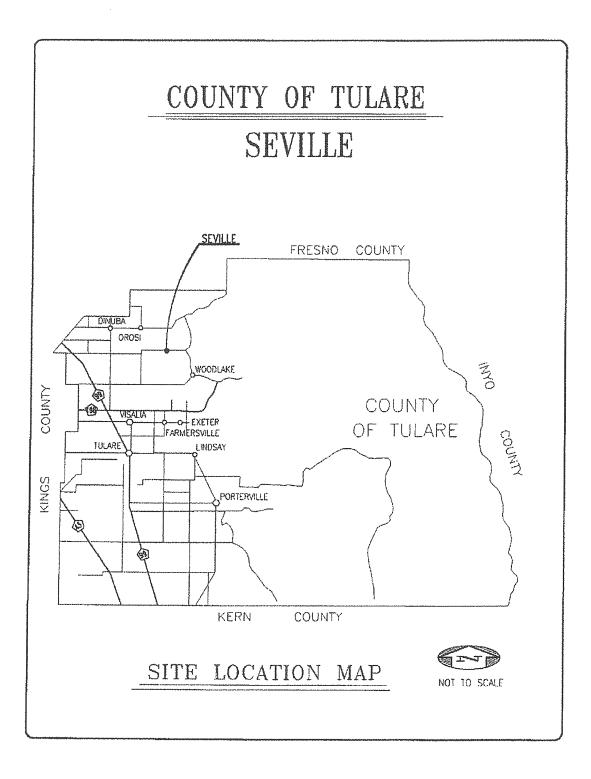
