SUMMARY:

The agreement will allow the County to collect and distribute East Orosi Community Services District's special assessments and the County's fee for services.

East Orosi Community Services District has authority per Government Code 61115 to levy rates or other charges and request they be added to the secured property tax roll as a special assessment.

FISCAL IMPACT/FINANCING:

The agreement provides for cost recovery of providing service. The fee for a special assessment fund is \$200 per year and \$1 per parcel when submitting electronically. No additional Net County Cost to the General Fund
