REQUEST(S):

That the Board of Supervisors:

- Approve the agreement between Lindmore Irrigation District and the County of Tulare to collect and distribute special assessments on the secured property tax roll.
- 2. Authorize the Chair to sign the Agreement

SUMMARY:

The agreement will allow the County to collect and distribute Lindmore Irrigation District's special assessments and the County's fee for services.

Lindmore Irrigation District has authority per California Water Code 22280 and 26653 to levy rates or other charges and request they be added to the secured property tax roll as a special assessment.

FISCAL IMPACT/FINANCING:

The agreement provides for cost recovery of providing service. The fee for a special assessment fund is \$200 per year and \$1 per parcel when submitting electronically. No additional Net County Cost to the General Fund
