SUMMARY:

Tulare County contracts security guard services to provide safe environments for County employees and the public at multiple locations Countywide.

The current contract with American Guard Services is set to expire on June 30, 2020. The County chose to request proposals for security guard services in lieu of exercising a renewal option with American Guard Services. In April 2020, the General Services Agency requested written proposals for security guard services. Proposals were submitted by seven vendors. After consideration by a multidisciplinary review team including the contract administrator, project management, and administrative staff, Fuentes Security Service received the highest overall score.

The scores were based upon the Best Value procurement practice, a combination of qualifications, experience, and price. A summary of scores for all seven vendors is included in Attachment A. Fuentes Security Service was determined to have the experience and qualifications to meet service expectations, maintain high standards

for employees, and respond to the needs of the County.

The proposed contract term with Fuentes Service is for one (1) year, effective July 1, 2020 and expiring June 30, 2021. The contract also stipulates an option to extend for an additional two (2) one (1) year periods by mutual written consent. However, the County reserves the right to terminate the contract, with or without cause, by giving a thirty (30) day written notice of intent to terminate.

It is requested the Board award the contract for security guard services to Fuentes Security Service, in the amount of \$2,833,000 with an annual extra work contingency of \$167,000.

FISCAL IMPACT/FINANCING:

There are no net County costs to the General Fund. Security guard services are paid for by the individual departments based upon their requests for service.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's Strategic Business plan includes the Safety and Security Initiative that provides for the safety and security of the public. These services will help to provide facilities where the general public and staff are enabled to conduct business in a safe and secure environment.
