SUBJECT: Approve a Custodial Budget Adjustment

REQUEST(S):

That the Board of Supervisors:

- 1. Approve an adjustment to the Custodial budget for Fiscal Year 2019/20 in the amount of \$230,000.
- 2. Approve the necessary budget adjustment per the attached AUD 308 (4/5ths vote required).

SUMMARY:

Tulare County contracts janitorial services to provide safe and clean environments for County employees and the public at multiple locations Countywide. Advance Building Maintenance is the contracted vendor responsible for providing janitorial services to all County-owned and select leased facilities outside the city of Visalia. The COVID-19 pandemic has prompted increased requests for deep cleaning and disinfecting of these facilities, thus, greater expenditures are anticipated this fiscal year than previously projected. Therefore, it is requested that the Board approve a budget adjustment of \$230,000 to cover the increased expenses.

FISCAL IMPACT/FINANCING:

There is no Net County Cost to the General Fund. Custodial services are paid for by General Services and then billed to individual departments. The budget adjustment request is to increase fund 068-068-3010-7043 by \$230,000 which includes costs for additional services already requested as well as contingency for any additional unanticipated requests.
