#### REQUEST(S):

That the Board of Supervisors:

- Approve the transfer of funds to Capital Projects of up to \$95,000 for long range Agricultural Commissioner Capital Asset projects.
- 2. Approve the necessary budget adjustments per the attached AUD 308 (4/5ths vote required).

#### SUMMARY:

The Tulare County Agricultural Commissioner/Sealer is requesting the Board of Supervisors approve the attached AUD 308 for Fiscal Year 2019/20, allowing \$95,000 from his Special Projects budget to be used for long range Capital Asset projects. These projects would include, but are not limited to, a solar system for the Tulare Agricultural Building, and parking lot repairs and/or repaving, including line striping. Usage of these budgeted funds will allow the Agricultural Commissioner to meet all of the conditions of his Maintenance of Effort with the California Department of Food and Agriculture as defined by Food and Agricultural Code 224.5.

#### FISCAL IMPACT/FINANCING:

The attached AUD 308 will allow for up to \$95,000 of the Agricultural Commissioner's budget to be transferred to a Capital Projects fund. The money will be held until such time that the project(s) are ready to be completed. There will be no additional Net County Cost.
