SUMMARY:
The agreement will allow the County to collect and distribute County of Tulare Community Facilities District No. 2019-01 (Services) special assessments and the County's fee for services.

County of Tulare Community Facilities District No. 2019-01 (Services) has authority per Government Code 53340 to levy rates or other charges and request they be added to the secured property tax roll as a special assessment.


FISCAL IMPACT/FINANCING:
