SUBJECT: Approve an agreement with Richard Sigmund

REQUEST(S):

That the Board of Supervisors:

- 1. Approve an agreement with Richard Sigmund to provide Hearing Officer Services for Certification and Riese Hearings in an amount not to exceed \$250,000 retroactive to July 1, 2020 through June 30, 2021. This agreement is retroactive due to delays in obtaining signatures from the vendor. It was impracticable for the Board to take action prior to July 1, 2020 due to the time needed to process, prepare and submit the agenda item.
- 2. Find that the Board has the authority to enter into the agreement as of July 1, 2020 and that it was in the County's best interest to enter into the agreement on that date.
- 3. Authorize the Chair of the Board to sign one (1) copy of the agreement.

SUMMARY:

The Tulare County Health & Human Services Agency (HHSA), Mental Health Branch, provides mandated services to Tulare County Mental Health Plan consumers. If a consumer is deemed a danger to others, themselves, or is gravely disabled due to a mental health impairment, they may be detained in a facility for treatment and evaluation per Welfare and Institutions Code 5250 and/or 5270.15. The consumer is entitled to a Fair Hearing that must be conducted by either a Certification Review

Hearing Officer or a Court Appointed Commissioner or Referee.

SUBJECT: Approve an agreement with Richard Sigmund

DATE: July 7, 2020

Richard Sigmund is the appointed secondary Hearing Officer for Tulare County Mental Health consumers. This appointment is needed to relieve the current Hearing Officer Ralph Agnello during times of leave and to establish a continuum of service when this occurs. The duties of the hearing officer have intensified due to an increase in the number of beds at Kaweah Delta Mental Health Hospital. It is anticipated that in Fiscal Years 2020 through 2021, Richard Sigmund will serve approximately 600 mental health consumers at Kaweah Delta Mental Health Hospital.

This agreement did not include a Request for Proposal (RFP) because per Welfare and Institution Code Section 5256.1, the Certification Review Hearing Officer is Courtappointed. Richard Sigmund, Attorney at Law has been selected by the Court as the secondary Hearing Officer for certification reviews and hearings within Tulare County.

The following term deviates substantively from the standard County boilerplate 1) Insurance requirements for General Liability and Worker's Compensation have been waived by Risk Management. Also, Risk Management waived the reduction limits for Auto Insurance.

FISCAL IMPACT/FINANCING:

The budgeted costs associated with this contract will be included in the HHSA 3311 budget, line 7043, professional services, for a maximum reimbursement of \$250,000 for Fiscal Year 2020-2021. The average estimated cost per consumer is \$133. The estimated amount is subject to change based on actual utilization. This agreement is funded with Mental Health realignment revenues. There is no additional net cost to the County General Fund.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year Strategic plan includes the Quality of Life Initiative to promote health and well-being for the citizens of Tulare County. The Hearing Officer will help fulfill this initiative by providing mandated legal services to our consumers.
