REQUEST(S):

That the Board of Supervisors:

- 1. Approve an amendment to Agreement No. 28768 with Micro Focus Software, Inc., to extend the term of the agreement to July 31, 2021 to provide user licenses and maintenance support for Micro Focus software including GroupWise email, Filr file sharing, iPrint mobile enterprise printing, and ZENworks desktop management, in an amount not to exceed \$332,125,11.
- 2. Authorize the Chair to sign the three copies of the Agreement.

SUMMARY:

The Information and Communications (ICT) Department is responsible for purchasing and maintaining the hardware and software contracts for the Information and Communications Technology assets of Tulare County, including but not limited to the mainframe computer, the data center servers, network infrastructure components and Storage Area Network (SAN).

Since 2013, the County has utilized Micro Focus, formerly Novell, products such as the email and scheduling program GroupWise, as well as Filr file sharing, iPrint mobile enterprise printing, ZENworks desktop management, and other vital office applications. The approval of this amendment would ensure the continued performance and support of these products.

AMENDMENT TO TULARE COUNTY AGREEMENT NO. 28768 WITH MICRO FOCUS SOFTWARE, INC. FOR THE PROVISION OF MICROFOCUS TRUE-UP

THIS AMENDMENT ("Amendment") to Tulare County Agreement Number 28768/ Contractor MLA Number 7126997 (the "Agreement") is entered into by and between the COUNTY OF TULARE ("COUNTY") and MICRO FOCUS SOFTWARE, INC. ("CONTRACTOR" or "Micro Focus") as of July 1, 2020, with reference to the following:

- A. The COUNTY and CONTRACTOR entered into the Agreement on July 31, 2018, for the purpose of providing Micro Focus True-Up services for a one-year term;
- B. COUNTY and CONTRACTOR now wish to amend the Agreement in order to extend the life and term of Tulare County Agreement Number 28768;

ACCORDINGLY, COUNTY and CONTRACTOR agree as follows:

- 1. Tulare County Agreement No. 28768 the Agreement is hereby amended to extend the term from August 1, 2020 and now shall be in effect through July 31, 2021:
- 2. Furthermore, for the services provided, the COUNTY shall pay to CONTRACTOR \$332,125.11.
- 3. Furthermore, section 6 is rewritten as follows: "This agreement is governed by the laws of the State of California. This Agreement includes the entire agreement with respect to the services between (a) Customer and (b) Micro Focus and its Third Parties with respect to the services. It may be modified only by a written agreement signed by the entity to the bound."
