SUBJECT: Approve an agreement with Kings View Corporation

REQUEST(S):

That the Board of Supervisors:

1. Approve an agreement with Kings View Corporation for the South County One-Stop Center program for mental health services in an amount not to exceed \$700,000 retroactive to July 1, 2020 through June 30, 2021. This agreement is retroactive due to delays in receiving signatures from the vendor. It is impracticable for the Board to take action prior to July 1, 2020 due to the time needed to process, prepare, and submit the agenda item.
2. Find that the Board has the authority to enter into the proposed agreement as of July 1, 2020 and that it was in the County's best interest to enter into the agreement on that date.
3. Authorize the Chair of the Board to sign one (1) copy of the agreement.

SUMMARY:

The Tulare County Health & Human Services Agency (HHS), Mental Health Branch, collaborates with Kings View Corporation to provide mental health services through the South County One-Stop Center under the Mental Health Services Act (MHSA) Community Services and Supports (CSS) component. The South County One-Stop Center is designed to offer a wide array of integrated services to youth ages 12 to 15, and transitional age youth ages 16 to 25. The

South County One-Stop Center administers a Children's System of Care model that promotes the integration of mental health services and quality of life approaches such as employment, education, drug/alcohol counseling, and life skills training. It is estimated that 30 unduplicated children ages 12-15 and 100 unduplicated transitional youth ages 16-25 will benefit from this agreement.

Tulare County Mental Health Branch released a Request for Proposal (RFP) in 2013 for the South County One-Stop Center. Only one proposal was received through the proposal process. After review of the proposal, the RFP Review Team recommended Kings View Corporation be awarded the contract. Kings View Corporation has a long history of providing quality mental health services in Tulare County and has been providing these services continually since being awarded the initial contract in 2006.

The prior agreement, which is identical except for the time period and dollar value, was approved by the Board of Supervisors on June 4, 2019. An amendment attaching Exhibit B-5, was approved by the Board of Supervisors on December 17, 2019.

The only changes to the previous agreement and amendment are to the time period of the agreement and the dollar value for budgeted amounts. The total price for services has not changed.

There are no substantive deviations from the standard County boilerplate.

FISCAL IMPACT/FINANCING:

The budgeted costs associated with this agreement will be included in the HHSA 3331 budget, line 7052 medical providers, for Fiscal Year 2020-2021 in an amount not to exceed \$700,000. The average cost per consumer is \$5,385. The estimated amount is subject to change based on actual utilization. This agreement is paid through State Medi-Cal reimbursement and MHSA revenues. There is no additional net cost to the County General Fund.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year plan includes the Quality of Life initiative to promote and encourage the provision of quality supportive services for individuals in Tulare County. Tulare County children and youth will benefit from the provision of mental health services delivered through this agreement with Kings View Corporation for the South County One-Stop Center.
