## REQUEST(S):

That the Board of Supervisors:

- 1. Accept the work for the construction of the Road 192 and Road 204 Rehabilitation Project, near the communities of Poplar and Tooleville, as complete by Agee Construction Corporation of Clovis, California; and
- 2. Authorize the Chair of the Board of Supervisors to sign the Notice of Completion; and
- 3. Direct the Clerk of the Board to have the Notice of Completion recorded with the County Clerk-Recorder.

## SUMMARY:

This Notice of Completion is for the construction of the Road 192 and Road 204 Rehabilitation Project. This project was completed within the allowable contract time and under budget. The work was performed by Agee Construction Corporation, under Tulare County Agreement No. 29332.

This project was approved by your Board on June 18, 2019 (Resolution No. 2019-0527). The lowest responsible bid was submitted by Agee Construction Corporation. On August 13, 2019, your Board awarded and approved a contract (Resolution No. 2019-0723) to Agee Construction Corporation in the amount of \$1,628,470.

This project included a combination of isolated pavement repairs, installation asphalt surfacing, full depth pulverization, asphalt surfacing, traffic stripes and pavement markings.

## SUBJECT: Notice of Completion for Construction of Road 192 and Road 204 Rehabilitation Project DATE: August 4, 2020

There was one (1) Contract Change Order (CCO) for this project with a net total cost of zero dollars written to allow contract items to exceed the 125% threshold without the need to provide an adjustment to the contract item unit price.

This project has been completed in accordance with the plans and specifications and is now ready for acceptance by the Board.

### FISCAL IMPACT/FINANCING:

No net County cost to the General Fund.

An allowance of 5.77% of the contract bid amount, or \$93,923, was authorized for contingencies at the time of award setting the total approved contract amount at \$1,722,393.

The final cost to complete this project was \$1,587,872.46 which is 2.49% below the bid amount and is 7.81% below the authorized contract amount plus contingencies.

This project was funded through the Surface Transportation Block Grant Program (STBGP) and Road Funds.

## LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

This project enhanced the safety and security of the public by improving the transportation infrastructure for both the general population in the region and the motorists using this facility.


